The firm has over 60 years of experience in the delivery of transportation projects nationally and globally. The firm's areas of expertise include program management and staffing, complex highway design, structural engineering, traffic engineering, rail, permitting, asset management, emergency management, and construction services. With offices in Lake Mary, Tampa, Pompano Beach and Miami, we offer project management and technical staff that provide quality products adhering to the Department's needs. Our Team has extensive experience with Districtwide (D/W), engineering management contract support to

various DOT clients both in Florida and throughout the nation. During this time, our Team has delivered a wide range of services, from work program planning and final designs to construction services, identical to the services identified in the scope for this contract. We have also provided in-house staff augmentation support to our clients.

Proposed Approach and Understanding of Critical Issues:

Project Intent and Scope - We will function as an extension of the District's staff in support of the Project Manager, Tim Phillips, and D1 staff. Our support will entail specific project assignments or provision of staff to support FDOT in-house personnel. Assignments under this contract will be issued by Task Work Order (TWO) on an as needed basis for a wide range of transportation services. Tasks may involve scope development, field evaluations, work program planning, PD&E, conventional design/bid/build, design/build, construction contract document preparation, right-of-way acquisition, traffic planning and operations, asset maintenance, structural inspections, public involvement, time and cost estimates, construction support, post-design services, ITS, constructability reviews, EDMS, etc.
