**A RESOLUTION AUTHORIZING SUBMISSION OF A WYOMING DEPARTMENT OF TRANSPORTATION CONGESTION MITIGATION AIR QUALITY (CMAQ) GRANT APPLICATION TO THE WYOMING DEPARTMENT OF TRANSPORTATION ON BEHALF OF THE GOVERNING BODY FOR THE BOARD OF COMMISSIONERS OF CONVERSE COUNTY, WYOMING FOR THE PURPOSE OF THE RESURFACING OF APPROXIMATELY 6.5 MILES OF COUNTY ROAD 34, JENNE TRAIL**

**WITNESSETH**

**WHEREAS**, the Governing Body for Converse County desires to participate in the Wyoming Department of Transportation's CMAQ Grant program to assist in financing this project; and

**WHEREAS**, the Governing Body of Converse County recognizes the need for the project; and

**WHEREAS**, the Wyoming Department of Transportation CMAQ Grant program requires that certain criteria be met, as described in Rules and Regulations governing the CMAQ program, and to the best of our knowledge this application meets those criteria; and

**WHEREAS**, the Governing Body of Converse County plans to match the requested CMAQ Grant from stockpiled in-kind materials in the amount of \$97,880;

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF CONVERSE COUNTY, WYOMING**, that a grant application in the amount of \$489,397 be submitted to the Wyoming Department of Transportation to assist in funding the resurfacing of approximately 6.5 miles of Jenne Trail, County Road 34.
