theft. As the years go by and your house appreciates, you should be reviewing your insurance coverage. Many homes are underinsured by 30 or 40 percent; this can be a much greater number in Jane Brothers Ludwig higher risk areas with floods and serious weather conditions,

like hurricanes. You should ask your homeowners insurance company for a "guaranteed replacement policy," which covers repair or replacement of damaged homes without a deduction for depreciation or a dollar limit. If an old TV set that is damaged in a fire costs \$500 today, replacement coverage will pay the full cost. Without it, the homeowners only receive the actual cash

value—the replacement cost minus depreciation. If the television has depreciated 50 percent, the actual cash value coverage will pay only half of the replacement cost of \$250. Replacement insurance will also pay the full costs of rebuilding a home. Unless a homeowners policy states that property is covered for its replacement value, the coverage is for actual cash value. An upgrade from actual cash value to replacement coverage normally raises the premium 10 to 15 percent. ### Rappahannock Phragmites committee continues to assist local landowners

Action Committee (RPAC) is conducting operations to control invasive stands of common reed, also known as Phragmites.

If left unchecked, the invasive plant will take over more beneficial marsh plants, such as big cordgrass, wild rice, and the rare sensitive joint-vetch, which is a Federally-threatened species, said volunteer Alice Wellford.

For the sixth consecutive year, the control efforts are being led by Wellford and staff of the Rappahannock River Valley National Wildlife Refuge. Funding is available from the Fish and Wildlife Service's Partners for Fish and Wildlife Program, allowing RPAC to again conduct operations at no cost to land-

A broad spectrum herbicide, with the trade name of "Habitat," was labeled by the Environmental Protection Agency for use in wetlands in 2003. RPAC will use this new product during its 2005 control program. Spraying will begin in August and continue through September, using a helicopter, boat, truck and backpacks.

A helicopter spray is also planned for Hoskins Creek, Mount Lancing Creek, and Piscataway Creek in the Tappahannock area. Hoskins Creek contains the worst infestation of Phragmites on the entire Rappahannock River.

"Phragmites is a tough plant to control," said Refuge Manager Joe McCauley. "We've had some success over the past five years, but if we don't keep after it, it comes right back.'

This is confirmed by the plant's re-growth along Hoskins Creek this year, after two years of spraying in 2002-03 appeared to have achieved some measure of control.

Wellford is pleased that landowners are more aware of Phragmites and that they are seeking help in learning how to control it. She encourages them to educate ported to the roots and kills the their neighbors and seek help if River.

"Joe McCauley and the Rappahannock Refuge staff have been the sustaining force behind the control efforts of RPAC," said Wellford. "Without their expertise and resources, the annual spray would not be possible. Donations of money and time from landowners in the area are also crucial. In the future, we will battle invasive stands on a landowner's property until the stands are a manageable size. Then we hope the owners will be able to treat it themselves.'

Wellford and refuge staff are available to assist landowners in identifying the invasive type of Phragmites, and will attempt to fit them into the spray schedule, if time and funds permit. All landowners who wish to participate must sign a Habitat Enhancement Partner's Agreement. For more information, call 333-1470.

On May 17, 1790, Henry Hinton petitioned the courts for permission to erect a tavern on the Courthouse bounds, "30 yards from the east door of the Court House." The court approved, "considering the same to be a public advantage." Some 215 years later, the building stands as the oldest private building in the historic district. It is known as the Lancaster Tavern.

The tavern was built on the easternmost portion of a 200-acre tract Hinton bought from James Tapscott in 1789. The specific mention of the distance between the tavern and the courthouse is the only reference found in any record to determine the exact location of the old Courthouse. When the tavern was built, the courthouse and prison were the only public buildings on the twoacre Courthouse Green.

Hinton held the property for about seven years, apparently making it his home and operating the tavern himself. In January 1795, James Waddy was licensed 'to keep an ordinary in the house lately occupied by Henry Hinton." Later that year, John Churles was the tavern keeper "at the house called Hinton's." In 1796, Spencer George presided at "Hinton's Tavern."

Licenses were not granted gratuitously. Certain standards of propriety were expected. Frequently, appended to the issuance of a license, it is noted that "the applicant is a man of good character not addicted to drunkenness or gaming and will keep an orderly and useful house of entertainment." Additionally, a tax was paid to the sheriff for the privilege and a bond with security held by the clerk of the county.

In 1797, the property was sold to William Stott. That year, the first official clerk's office, (the eastern half of the existing clerk's office) was built immediately across the road from the tavern. This was a decided advantage to local entrepreneurs. The number of people coming to the site to conduct legal business greatly increased. Coming considerable distances on horseback, wagon or light carriage, crossing rough fields and following dusty roads, the local citizenry was in need of a place to rest, socialize and quench thirst.

For the next 100 years, the tavern property was sold, leased and inherited by a spectrum of society. Some were wealthy and were large landholders, others depending on it for their livelihood and at least one owner surrendered his ownership to satisfy an indebtedness. From 1847 to 1849, the Masons met at the tavern then owned by Lewis Dix, while their new lodge was being

built several hundred feet to the

Sarah George, the first woman to operate the ordinary, leased the building from James Sullivan in 1881. The deed that describes the transaction indicates that she was a woman with remarkable business acumen. She stipulated that the owner "have the dining room of the hotel put in good repair, the barn, shed and stable newly covered and front porch of the hotel thoroughly repaired." The porch was removed when the road was widened in 1938. Her five-year lease, with an option to extend it, specified a \$150 annual

Sarah George's enterprise eminently successful. A personal testimony to that effect is noted in "A Journal of Our Pilgrimage to the Northern Neck" by Robert Randolph Carter of Shirley Plantation in the Northern Neck of Virginia Historical Magazine, Vol. XLV. "But for the rain, we might have taken, en route, Kilmarnock and 'White Chapel' with its tombs of the Balls,...or even gone by 'Ditchley' the old Lee mansion in Northumberland County...But by following the road to Lancaster Court House, we brought the wind in our back and arrived there dry, at Mrs. George's clean and cosy inn, where we found shelter from an Easterly storm of rain and wind

which time it served as a public house, the property was sold to William Chilton, the Clerk of the county, and was then a private home. It was a commodious residence for Chilton's large family, with four bedrooms upstairs and seven fireplaces keeping it snug and comfortable. Eight of Chilton's children were born in one of those bedrooms.

Oscar B. Chilton inherited the old tavern property where he and his wife, Lila Combs Chilton, made their home. He followed in his father's footsteps, and served as the county clerk.

In 1973, widowed and incapacitated by illness, Lila Chilton sold the house and property to Jeremiah O'Meara, a dentist who converted the kitchen for use as his dental office. As the building approached the two-century mark, another exciting change took place.

In 1982, Ann Thomas Parsons (Carter), bought the house and restored it to its original use, naming the building, "The Lancaster Tavern." For over a dozen years, she operated a restaurant and meeting place.

The most recent owner, Louis Fletcher, who purchased the tavern and several adjoining properties, made a valiant effort to continue the tradition of offering wholesome food and hospitality to the public. The building, with an upper floor rental, stands today, a silent witness to over two centuries of history, awaiting a
