e. Statement regarding prequalification of consultant or proposed subconsultants in advertised type of work:

Florida Acquisition & Appraisal, Inc. (FLAA), a FDOT Certified Small Business (BDI), knows the requirements of a districtwide contract like the subject. Florida Acquisition & Appraisal, Inc. has been FDOT prequalified to provide Right of Way (ROW) services since 1995. Jack Curatelli has directed, managed or provided production related ROW services in all of FDOT Districts 1, 2, 3, 4, 5, 6, 7 and the Turnpike. FLAA and its principals are providing, or have provided county-wide services for Polk, Hillsborough, Manatee, Sarasota County, City of Lakeland, City of North Port and many other counties, cities and surrounding areas. FLAA principals and staff have provided project and management services on more than 30 district-wide contracts. FLAA provided District 1 district-wide acquisition and appraisal tasks including cost estimating, business damage estimating, management, acquisition and relocation on projects such as the I-4 corridor, In-town Bypass, SR 540, SR 542, US 17, SR 739 and others. FLAA is currently providing district-wide contract services for Districts 4, 6 and 7 (ITN), and several GEC/Misc. Engineering Services contracts, including right of way support services in the surrounding areas. FLAA recently provided the ROW Production arm for the Hillsborough County Transportation (HNTB) Task Force providing four personnel to assist in the re-evaluation of the ROW program. As part of that acceleration effort, FLAA conducted more than 125 cost estimates and presented changes to the ROW procedure to expedite the County's process. In addition, FLAA provided ROW cost estimating and continuing services for the High Speed Rail Authority (Phase 1, Part 1).

f. Proposed key personnel and their proposed roles:

Jack has 30 years of experience working directly for and with the FDOT on district-wide Appraisal/Cost Estimating/Acquisition and other full service ROW contracts and is currently assigned project manager on 5-year district-wides in District 4 and 6 (soon to expire) and FLAA is also currently providing ROW support in District 7 under Lochner's GEC contract. Jack has directed or managed District 1 District-wide appraisal and acquisition contracts and is a former District Four Project Manager and Suit Coordinator. He has managed numerous FDOT District-wide contracts as a consultant in Districts 1, 4, 6

and 7, as well as numerous project specific contracts for most of the Districts and the Turnpike Enterprice (Polk Parkway & Suncoast Parkway). Jack is currently managing the District 1 SR 542 acquisition contract from 1st Street to Buckeye Loop Road project.

Steve Popowiecki, Right of Way Agent is a 10 year real estate veteran and shall provide key cost estimate support on District projects as he was instrumental in the FDOT/TBARTA Pinellas Alternatives. Steve is currently negotiating properties for SR 542 and participates in task management as appropriate.

Mark Meeks, SR/WA, Property Appraiser/Reviewer, URS, shall assist Jack as needed. Mark brings not only his expertise as a FDOT review appraiser but his URS appraisal litigation support team in addition to FLAA's proposed subject matter experts noted. Mark personally is available for review assignments and he and his firm shall assist FLAA in Appraisal and Appraisal Review management support. Mark's ROW experience includes appraisal/review services for negotiation and litigation purposes, cost estimates, design support, and project management. Mr. Meeks worked for the Florida Department of Transportation, District Five for over 20 years, and is fully versed with the Uniform Standards of Professional Appraisal Practice (USPAP) and the FDOT Supplemental Standards of Appraisal.

i. Project Approach and Understanding of Critical Issues:

Florida Acquisition & Appraisal, Inc. (FLAA), a FDOT Certified Small Business (BDI), knows the requirements of a Districtwide or Miscellaneous Land Acquisition/Appraisal/Appraisal Support Services contract like this. We know that the critical facet of a project

such as this is to be a relevant, responsive resource to FDOT, District 1 and to assist this District in meeting its goals whether appraisal/appraisal review, appraisal support, cost estimating, acquisition aerial cartography, business damages or other scope related production management or staffing. FLAA will provide the platform for which the appraiser or subject matter expert shall be able to conduct the scope of work it's been assigned while FLAA or one of its Task Managers/Subs manage the task and delivery of the product on time, either using our own schedules, primavera or the Department's Project Scheduling and Management (PMS). FLAA understands and is well known for its ability to manage Districtwide contracts whether the tasks are appraisal/review, cost estimating, acquisition or full service miscellaneous or large project parcel specific tasks. We also understand under this contractual scenario that work issued under this contract could be large, small or none at all. There may be limited specific tasks with which the District needs assistance, or there could be staffing or an entire full service project issued. FLAA has assembled a dynamic redundant quality team which allows the flexibility to meet the District's needs, no matter in which corner of the 12 Counties the project is located. We have teamed with a cadre of specialists known to the Department as well as a full service appraisal support group in URS and Kelly, Collins and Gentry and a relocation/acquisition group Keystone Field Services, DBE. Florida Acquisition & Appraisal, Inc. (FLAA) and its team's philosophy in developing a quality assurance plan begins with utilizing highly experienced skilled and knowledgeable staff and Quality Assurance and Compliance reviewers. Our skilled reviewers, coupled with a clear understanding of the District's Appraisal Guidelines (DAGs), FDOT ROW Manual Chapter 6, Section 1, Appraisal & Appraisal Review, with Section 2, Supplemental Standards, USPAP together with the overall objectives of the District's appraisal project, are the foundation of our Quality Assurance Plan. We have proven quality assurance initiatives based upon FDOT regulations.

FLAA has developed a proactive QA/QC process, the basis of which is Tallahassee's QAR form, to assist in assuring all elements of the appraisal process, parcel specific issues (access, legal, special damage studies etc.) and particularly format are addressed and reported. This QA/QC checklist will be attached to the appraisal file and will be referred to during the entire appraisal process and is "checked off" at periodic (weekly) intervals as tasks are adequately completed.

FLAA's main office is in Tampa, with an auxiliary offices in Lakeland of our own or subconsultant reciprocal arrangements. In addition, we also have cooperative office arrangements available in Southeastern Florida, and our subconsultants, Keystone Field Services, are based out of Tallahassee. Jack Curatelli, SR/WA and many of the staff noted above have either directed, managed or provided production-related ROW services directly on District 1 projects, notably a District 1 Districtwide Appraisal Contract with assignments on (2) SR 739 & SR 45 Districtwide Acquisition/Relocation on the In-Town By-pass. Most recently direct acquisition contracts on SR 542, and US 17 and prior to these projects FLAA specifically provided ROW services on districtwide contracts for acquisition and appraisal, cost estimating, business damage estimating and management, acquisition and relocation, districtwide suit and litigation support, and other direct projects, as well as property management staffing. FLAA was the ROW production arm for the Hillsborough County Transportation (HNTB) Task Force, providing four staff people to assist in the reevaluation of the ROW Program.
