\$65 – includes bus, lift ticket, and rental - excluding helmet rental \$25 – BUS ONLY FEE- for students with a Ski Pass to Morin Heights \$10.35 – helmet fee *mandatory if you do not have your own helmet*

Grades: 7 -12 students

Minimum of 25 participants needed for bus.



IMPORTANT SKI TRIP INFORMATION

- If buses are cancelled the day of the Ski Trip the trip is cancelled. Listen to local radio stations the morning of the trip.
- If there is inappropriate weather (i.e. thaw, ice rain, temperature) an announcement will be made ONE DAY PRIOR to the ski trip if a cancellation will occur.
- All equipment may be stored at the Char-Lan Arena the morning of the Ski Trip. Please note that it is the student's responsibility to ensure they pick up their equipment and load it onto the designated bus.
- ALL STUDENTS ARE REQUIRED TO RIDE THE BUS TO AND FROM THE SKI TRIP. This is mandatory. No student will be permitted to have a parent or guardian drive them to or from the trip.
- CANCELLATION: Students are required to give South Glengarry Recreation 2 days' notice prior to ski trip
 if they are no longer able to attend. Those who do not meet this requirement will NOT be offered a refund.
- Any NSF cheques will be charged a \$25.00 fee plus the cost of the trip.
- Please Note: It is the responsibility of the individual renting the equipment to return the equipment without damages. If lost, stolen or damaged; replacement charges will follow at the <u>expense</u> of the <u>renter</u>.

MOUNTAIN CODE OF CONDUCT

Code adopted under the Act respecting safety in sports. This Code applies to all persons practicing snow sports.

- Remain in control of your speed and direction. Make sure you can stop and avoid any person or obstacle.
- Yield the right of way to persons downhill and choose a course that
 ensures your safety. Yield the right of way to persons uphill when entering a trail and at
 intersections.
- Do not stop on a trail or obstruct a trail if you need to stop you must ensure that you are visible to skiers from above
- If you are involved in or witness an accident, remain at the scene and identify yourself to a first-aider.
- Use and wear at all times a proper device to prevent runaway equipment.
- Keep off the lifts and trails if your ability is impaired through use of alcohol or drugs.
- Obey all signs and warnings and never venture off the trails or onto a closed trail.
- It is prohibited for any skier to wear an, MP3, or other device.

There are elements of risk that common sense and personal awareness can help reduce. Regardless of how you decide to use the slopes, always show courtesy to others. Observe the code listed above and share with others the responsibility for a great outdoor experience. You must obey all other rules and signs pertaining to any particular activity as marked out by the resort. Failure to do so will result in confiscation of your lift ticket and removal from the Mountain.
