<u>Important information when making an application to register an</u> employment agreement.

Where an applicant that is a trade union of workers, and where the application is made jointly by more than one trade union of workers, each such trade union, shall furnish the Court with a Statutory Declaration within the meaning of the Statutory Declarations Act 1938, made by a person authorised in that behalf by the trade union, containing the following particulars:-

- (a) The name of the applicant trade union;
- (b) The position held by the declarant;
- (c) The registered address of the applicant trade union within the State;
- (d) The number of workers of the class, type or group to which the agreement relates who are members of the trade union of workers on whose behalf the application is made;
- (e) The number of workers of the class, type or group to which the employment agreement relates who are normally employed by the employers to which the agreement relates;
- (f) The declarant's means of knowledge of the matters referred to at paragraphs (d) and (e).

Before proceeding to consider the application the Court may request an applicant or any other party to the agreement to furnish:-

- (a) Such additional information as it may require;
- (b) Such further evidence as it may require in support of the statements contained in the application form or in the Statutory Declaration provided in support of the application;
- (c) Such evidence of the publication required by section 8(4) of the Industrial Relations (Amendment) Act 2015, as the Court may specify.
