About the Program

The 2010 Tax Relief Act provides an extraordinary window of opportunity for estate planning. Strategies for minimizing taxes on lifetime and testamentary transfers within the family are covered. The discussion focuses on accomplishing family goals to meet specific member needs. The program facilitates choosing an effective organizational structure for management and intergenerational transfers of unique forestry assets. Flexibility for addressing the uncertainty of current and proposed tax law changes to protect forestry assets are discussed. A working knowledge of federal estate and gift tax laws and regulations is provided to enhance communications with estate planning advisers. This program will enhance your understanding of managing forest assets before and after retirement. Examples are used to illustrate various planning alternatives for forest properties with ample time for questions.

Who Should Attend?

Forest landowners, forestry consultants, landowner assistance and extension foresters, accountants, attorneys, and real estate agents and appraisers, as well as others who work with forest owners in matters pertaining to tax and estate planning.

He has written numerous technical publications on forestry investment analysis, timber taxation, and forest management. His tax columns in forestry magazines are widely read. Dr. Haney manages the family tree farm with his wife and daughter.
