



Directors personal guarantee deed to AIG Life Limited

This is an important document. Before you sign it, you should:

- read it carefully;
- get advice from a solicitor; and
- ensure you understand what it means and what the implications will be on signing and witnessing this document.

Please note that all Directors/Partner Members should sign the Directors Personal Guarantee Deed.

Execution of the deed requires each guarantor's signature to be independently witnessed (ie, by someone other than an employee of the firm or a relative of the directors).

If you do sign this document you might have to pay some of the debts of the intermediary identified in this guarantee, if that intermediary fails to do so and you will have other obligations as well.

Your commitment to pay will be unconditional but there is a limit to the amount that AIG Life Limited can ask you to pay as set out in the Guarantee.

In consideration of AIG Life Limited ("AIG") extending business facilities to

to perform its obligations, pursuant to the terms of the

Intermediary Business Agreement (together the "Debt"); and

I/we the undersigned jointly and/or severally guarantee the payment of all monies due to AIG from

Each signatory's maximum total liability under this guarantee shall be:

(i) in respect of the party of the Debt that is due to AIG at any time in respect of principal and/or capital, £1,000,000 (one million pounds sterling); and

(ii) In respect of all other parts of the Debt (including but not limited to interest, costs, commission clawback and expenses due to AIG), its full amount at any time.

I/we agree that I/we shall not be exonerated by reason of any variation or alteration or indulgence of any kind given or granted to any party (with or without my/our knowledge or consent) in connection with the above appointment and that this guarantee shall continue in force unless and until revoked in writing by AIG under the hand of one of its Directors.

I/we agree that AIG shall not be obliged to take any action or obtain judgement against

before taking steps to enforce any of its rights or remedies under this

guarantee [and AIG or any of the companies in AIG group can enforce each of my/our obligations under this guarantee].

- 3) Execution of the deed requires each guarantor’s signature to be witnessed (ie, by someone other than an employee of the firm or a relative of the directors).
