

# Community Benefit What Counts: The Gray Areas

#### Overview

Hospitals today are recognizing the need to re-emphasize their charitable mission in fulfilling community benefit expectations. With rising healthcare costs and concerns about quality and safety, there is a cry for increased transparency and accountability. Health Care Reform calls for the IRS to review a hospital's community benefit every three years. State and local governments are scrutinizing whether not-for-profit hospitals are meeting expectations in exchange for tax exemption. Consumers and employers are looking for new approaches to rising healthcare costs and looking to hospitals, the community's largest healthcare entity, as key partners.

In this era of increased emphasis on community benefit, hospitals must be able to accurately report community benefit. **Reported community benefit activities must follow the IRS definitions and be categorized correctly.**

Further with CHA, she staffs the national "What Counts" hotline and serves as lead faculty for the CHA Community Benefit 101 workshops.

While working for VHA Inc., Patsy coordinated four national community benefit conferences and remains the community benefit resource expert for VHA members including implementing the Lyon CBISA Online Software. Based in central Ohio, she has served as vice chair of the Ohio Hospital Association's Foundation for Healthy Communities Board which funds innovative projects that improve community health status. Patsy was also vice chair of the Hospital Commission of Franklin County (Columbus), a board that reviews and recommends tax-exempt bond issuance for healthcare organizations. Appointed by the county commissioners, her role on this Commission was to assure that community benefit was discussed in the requesting hospital's petition for tax-exempt bonds. Patsy holds master degrees in Public Policy and Management and in Social Work from The Ohio State University.
