## CONDITIONS AND REQUIREMENTS:

**Meet Announcement, advertising and the Meet Program must bear conspicuously the statements:**

**"Held under the Approval of Adirondack Swimming, Inc."**

**"The designated representative agrees, on behalf of the swimming organization applying for this approval, to abide by and govern this event under the Rules and Regulations of USA Swimming, Inc., Adirondack Swimming, Inc. and all other terms and conditions upon which this Approval may be granted."**

Approvals issued to one organization cannot be transferred to another organization.

In granting this Approval it is understood and agreed that USA Swimming, Inc. and Adirondack Swimming, Inc. shall be free from any liabilities or claims from damages arising by reason of injuries to anyone during the conduct of the event.

An Approved event must be observed and run according to the rules set forth in the "USA Swimming Technical Rules". A minimum of two (2) USA Swimming Certified Stroke & Turn Officials must be on deck at all times during the meet, one located at each end of the pool. Although all athletes do not have to be members of USA Swimming, Inc., any athletes wishing times to be entered to SWIMS must be currently registered to USA Swimming.

**The Organization will email the FULL Meet Manager file (or backup) of the meet to the AD Sanction Chair...**

1. With this application, with the meet file being properly set up for Posting the Events file to the AD Web Site.
2. When the meet is completely seeded (*at least 5 days in advance*) for Registration Reconciliation for USA-S Athletes. and for posting Psyche Sheets to the AD Web Site.
3. When the meet is completed (*within 5 days*) for Results for USA-S Registered Athletes to be Uploaded to SWIMS And for posting of Official Results to the AD Web Site.

Approval may be withheld or withdrawn by Adirondack Swimming, Inc. if the competition was not conducted in accordance with the above requirements.

Please Note: Approved Meets do NOT fulfill minimum meet attendance requirements for Adirondack Championship Meets. All times achieved in Approved meets, by USA Swimming registered athletes, may be used for entry qualification in Any Sanctioned Meet. Please keep in mind, times are recorded from legal events only. For example, Mixed Gender Relays are not legal events and no times from these events will be recorded to SWIMS.
