The Centennial School District Budget Committee is composed of fourteen members; seven elected school board members and seven citizens appointed by the Board. A member cannot be an employee of the school district. The fourteen volunteer members review and approve the amount of the proposed budget. The committee may direct the administration to make dollar adjustments (increases or decreases) to the total before they approve the budget. The Budget Committee does not approve new personnel, employee contracts or salary/benefits. The Board of Directors is responsible for determining the District's programs.

The Budget Committee reviews all financial information at budget committee meetings scheduled for December 9, 2015, April 20, 2016 and May 18, 2016. It is expected that members will make every effort to attend those meetings. The December meeting is scheduled at 6:00 p.m. and the April and May meetings are scheduled at 7:00 p.m. on Wednesday evenings. All meetings are at the District Office.

The Board of Directors is asking interested applicants to complete the attached application and return it to the office of Director of Business and Operations no later than 3:00 p.m., October 23, 2015.

This personal information will be considered by the school board members when appointments are made. The applicants will also be asked to make a brief personal statement during the November 18, 2015 board meeting at the Centennial District Office, 18135 SE Brooklyn St., Portland, OR. at 7:00 p.m. The Board will then make an appointment to the 2016-2017 Budget Committee. All information submitted becomes public information.
