

2015 -2016 Verification Worksheet Federal Student Aid Programs

Your Free Application for Federal Student Aid (FAFSA) is selected for a review process called "Verification." In this process, Central Arizona College (CAC) will be comparing information from your application with signed copies of you and your parent(s) 2014 federal tax return transcripts and/or other financial documents. The law states that before awarding Federal Student Aid, we may ask you to confirm the information you and your parents reported on your FAFSA. If there are differences between your application and your financial documents, your FAFSA information will then need to be corrected. If you have any questions about verification, contact your financial aid office as soon as possible so that your financial aid will not be delayed.

What you should do:

1. Complete and sign the worksheet –you and least one parent. Do not leave any sections blank, any blank sections will be valued at zero.

- 2. Collect you and your parent(s) financial documents (federal tax return transcripts).
- 3. Talk to your financial aid office if you have questions about completing this worksheet.
- 4. Submit this completed worksheet along with tax return transcripts, and any other documents to your financial aid office.
