## Marriage Forms Helper - Instructions

- **Fill in the common pieces of data on page one. This information should all be gathered before the priest or deacon sits down to interview the couple.**
- **Much of the data on page one is automatically filled in on the following forms.**
- **Exceptions:**
  - **The Catholic's name and baptismal information must be copied and pasted onto the Form B (or simply re-entered).**
  - **If there are two Catholics, use the groom's name in the "Catholic" spot so that we enter these into the diocesan register in a uniform manner.**
- **Printing**
  - Print only the necessary forms
  - Always used: Forms A & F.
  - Often needed: Forms B & C.
  - Note: There are two Form F's generated, one for each member of the couple.
- **Filling out the remainder of the paperwork**
  - If desired, other fields on the forms may be filled out online.
  - One could interview each member of the couple separately, and then print the completed forms.
- **Some questions and answers are not really valid until after preparation is complete. Therefore, they SHOULD NOT be filled out except by hand.**
- **Don't mail the Form F's until after the wedding takes place!**
