

Villa Angela – St. Joseph High School Homecoming Dance Contract and Application

I/We agree to the following:

- To demonstrate good character and follow all school rules;
- To be respectful and courteous to other students, faculty, chaperones, and site employees;
To adhere to the school accepted dress code;
- To submit to a coat, bag, and container search upon arrival;
- To refrain from consuming illegal substances before, during, and after the dance. Any student suspected to be under the influence of an illegal substance will be subject to a breathalyzer test. Refusal to submit to the breathalyzer test is an admission of guilt;
- To arrive between 7:00 and 7:30 PM and not leave prior to 11:00 PM. This includes leaving and reentering;
- To refrain from any sexually explicit dancing, including freaking, grinding, or any other type of dance that could be construed as vulgar or provocative. All dancing will be face-to-face. All dancing will remain upright. No dancing that simulates sexual activity, nor is any intimate touching allowed.

Violating any portion of this dance contract will result in:

- a) removal from the dance;
- b) parents and/or guardians bring be notified:
 - that the student involved must leave the dance, or
 - that the student is to be picked up by parent/guardian immediately;
- c) adult guests being handed over to the policeman on duty.

Any student found to be in violation of substance abuse policy will receive a 5 day out of school suspension and have a dependency evaluation before being allowed to return to school. Parents will be called to pick student up from dance. If parents cannot be reached, or refuse to pick up, VASJ administration will alert proper authorities. Additionally, Any VASJ student found to be in violation of the prohibition of the illegal substances provision of the contract forfeits his/her right to participate in all end-of-year activities, including Prom, Graduation, and Baccalaureate.

All rules and regulations of the Villa Angela-St. Joseph High School handbook are operative at all school events. School Officials retain the discretion to apply these rules and regulations to protect the safety and well-being of all participants at the dance.
