Payment for monthly parking must be received no later than the 25th day of the preceding month. 4. All payments received for monthly reserved parking spaces are non-refundable. 5. Vehicles must fit within the assigned parking space. 6. Vehicles that are not parked in accordance with these policies may be subject to immediate termination of monthly parking privileges, citation, and/or towing. Partial refund for unused days will not be issued. 7. Applications must be legible and completed in full with signature. Incomplete or illegible applications will be rejected. 8.
