- THE APPLICATION IS APPROVED ONLY IF THE LESSEE DOES NOT HAVE ANY FINANCIAL OR DOCUMENTARY ARREARS BEFORE THE LESSOR.
- UPON ACCEPTANCE OF THE APPLICATION FOR PROCESSING WE PRESENT THE PROPERTY TO THE BUYER WITHIN 5 WORKING DAYS.
- THE LEASE CONTRACT EXPIRES AFTER PERFORMANCE OF ALL THE OBLIGATIONS ARISING FROM IT.
- THE MOTOR THIRD PARTY LIABILITY INSURANCE POLICY IS TERMINATED UPON THE WRITTEN CONSENT OF THE LESSOR AND AFTER PERFORMANCE OF ALL OBLIGATIONS.
- IF THE LESSEE HAS NOT EXPRESSED ANY WISH TO TERMINATE THE INSURANCE CONTRACTS/TO MAKE THE INSURANCE CONTRACTS PREMIUM-FREE AND/OR NOTED THE START DATE OF TERMINATION OF THE INSURANCE CONTRACT, THE LESSEE WILL CONTACT THE INSURANCE COMPANY WITH THE RESPECTIVE REQUEST ITSELF.
- IF THE PREVIOUS LESSEE DOES NOT FILE THE APPLICATION FOR TERMINATION OF THE MOTOR THIRD PARTY LIABILITY INSURANCE CONTRACT BEFORE THE DETAILS OF THE OWNER OR RESPONSIBLE USER OF THE VEHICLE ARE CHANGED IN THE MAANTEAMET, THE PREPAID PART SHALL BE TRANSFERRED TO COVER THE POLICY OF THE NEW OWNER OR RESPONSIBLE USER (LESSEE) OF THE VEHICLE.
- THE LESSEE UNDERTAKES TO REGISTER THE OBJECT OF LEASE IN THE MAANTEAMET NOT LATER THAN WITHIN 30 DAYS AFTER THE ISSUE OF THE DOCUMENTS OF THE LEASE CONTRACT.
- TO RESTORE THE CONTRACT OR RE-FORMALIZE THE INVOICE AFTER THE ISSUE OF FINAL INVOICE THE FEE SHALL BE TAKEN ACCORDING TO PRICELIST OF SWEDBANK.
