## Consignment Agreement

This agreement is made between you, \_\_\_\_\_ (the consigner) and Dressella's Designer Consignment.

At Dressella's we take pride in quality gently worn and new merchandise therefore we only accept items that are in like-new or new condition. Dresses should be dry-cleaned, free of stains, odors and tears. With professional alterations only please.

Dressella's will evaluate the merchandise once it is received and price the item in agreement with the Consigner, according to condition, style and designer. All dresses should be approved by Dressella's before shipping the dress to us. You can send an e-mail with a photo of the merchandise to Valerie@Dressellas.com and we will give you an estimate based on the photo.

Dressella's agrees to pay the consigner 60% of the sale price of the merchandise. There is a \$5 service charge, which will be deducted from the sale price before the 60/40 split.

The consignment agreement is based on a 1-year period on-line, if the item doesn't sell we will send the seller an e-mail to see if they would like to continue showing the item on our website, wish a reduced sale price, or if the seller wishes us to ship it back to them. We will ship the item back to the seller at the seller's expense. Shipping may take 14 days.

Should the consigner wish to terminate this agreement, they certainly may do so with a 15 day notice It is the seller's responsibility to pay shipping costs should the seller want the item back at anytime. Shipping the dress back to the seller can take up to 14 days. Dressella's is not responsible for damage during shipping. Seller may insure package at seller's expense.

Dressella's Designer Consignment is a formal dress broker and can not hold insurance for inventory it does not own. We are careful and trustworthy and will handle your dress with the utmost care, but assume no liability for fire, flood, theft, damage or wear. The dress is being handled and tried on therefore some wear should be expected at the time of pick-up.
