#### **Question Period**

Alan Toms, 10 Sunset Drive, L9W 2G9, asked Council if a zero tax rate increase would be established.

#### **Continuation of Operating Budget**

#### 0% Tax Rate/Tax Levy

Mr. B. Parrott, Treasurer, advised that, based on updated information and Council's decisions to date, the change in Town property tax on an average assessment of \$313,701 would result in a change of \$17.66 over 2014.

#### **Defibrillators in Municipal Buildings**

Alan Toms, 10 Sunset Drive, L9W 2G9, advised that his workplace requires staff to complete annual training for defibrillators and stated that verbal instructions provided by defibrillators are not a replacement for training.

And that two defibrillators be purchased for the Operation Centre and Water Pollution Control Plant at a total cost of approximately \$5,000.00, plus taxes.

#### **In-Year Savings**

Mark Whitcombe, 34 Blind Line, commented that Council was elected to govern and make decisions and that budget decisions need to be made by Council.

#### 7 Moved by Mayor Williams

That a line item of .61% or \$178,345 of in-year savings be included in the 2015 operating budget to achieve a zero % tax rate increase.

### **Orangeville Hydro Dividend**

Alan Toms, 10 Sunset Drive, stated that the hydro dividend belongs to the residents who paid for hydro and should not be part of the budget discussions.

### 8 Moved by Councillor Garisto

That \$178,345 from the hydro dividend be applied to the operating budget to achieve a zero % tax rate increase and that the balance of the hydro dividend be refunded to Orangeville Hydro customers.
