23	the Trustee in Items #1, #2, #3 and #4 of the Trustee's Recommendation dated January 3, 2006. In		
24	addition, income verification must be provided for the Months of June, July and August 2006.		
25	4. As of the date of this Recommenda	ation, the Trustee has been provided a copy of the	
26	pre-audit statement only from sale to date. The Trustee the requires a copy of the final escrow		
27	settlement statement.		
28	5. The Trustee requires that any Oro	der confirming the Plan and motion include the	
	provision that Saxon Mortgage has been paid thro	ough the sale of the property.
