June 1st deadline to submit AD-1026 form to receive premium subsidy on crop insurance

United Fresh recently published an email regarding the 'interim rule for Conservation Compliance requirements' for growers who participate in USDA programs. Prior to the 2014 Farm Bill, conservation compliance requirements applied to marketing assistance loans, farm storage facility loans, and payments under commodity, disaster, and conservation programs. The new Farm Bill added a provision which expanded this requirement to growers who are eligible and receive Federal Crop Insurance subsidy benefits.

want to continue receiving the federal premium subsidy, must certify their status by June 1st by turning in the AD-1026 form to USDA. Growers may have already received a letter in the mail from USDA regarding this new rule, as they have sent out more than 55,000 letters to growers who have crop insurance but do not have an AD-1026 form on file with the FSA.

## REFERENDUM PASSES: Georgia Agricultural Commodity Commission for Vegetables Reinstates Marketing Order

Georgia vegetable growers have a new marketing order. The Georgia Agricultural Commodity Commission for Vegetables -Marketing Order for Vegetables was approved with 92% of eligible growers responding in favor of the new assessment during the balloting period of March 1 through March 30.

For a vote to be valid, a least 25% of the eligible ballots must be returned. This new marketing order replaces the marketing order which failed passage in 2014 due to a lack of returns.
