

**FIRST AMENDMENT TO THE STANDARD FORM OF AGREEMENT BETWEEN
THE SCHOOL BOARD OF PALM BEACH COUNTY, FLORIDA
AND**

DUNKELBERGER ENGINEERING & TESTING, INC.

**PROJECT NAME: GEOTECHNICAL ENGINEERING/CONSTRUCTION MATERIALS TESTING/THRESHOLD
INSPECTION SERVICES ON CONTINUING CONTRACT**

This First Amendment made this 19th day of May 2011, to the Agreement regarding Geotechnical Engineering/Construction Materials Testing/Threshold Inspection Services on Continuing Contract, entered into on July 17, 2008 by and between THE SCHOOL BOARD OF PALM BEACH COUNTY, FLORIDA (the "School Board") and Dunkelberger Engineering & Testing, Inc., located at 1225 Omar Road, West Palm Beach, FL 33405, to provide Geotechnical Engineering/Construction Materials Testing/Threshold Inspection Services on Continuing Contract.

Whereas, the School Board wishes to exercise its first of two options to renew the Agreement dated July 17, 2008.

Now, therefore, the parties hereby agree that:

1. The July 17, 2008, Agreement regarding the Geotechnical Engineering/Construction Materials Testing/Threshold Inspection Services is hereby renewed for the first option to renew starting July 17, 2011 through July 16, 2012.
2. The July 17, 2008 Agreement shall be amended via interlineation to add the following provisions:
 - 8.14. Mandatory Nondiscrimination – As specified in Board Policy 6.144, the Consultant shall not discriminate on the basis of race, gender, gender identity or expression, religion, national origin, ethnicity, sexual orientation, age, or disability in the solicitation, selection, hiring, or treatment of subcontractors, vendors, suppliers, or commercial customers. Consultant shall provide equal opportunity for subcontractors to participate in all of its public sector and private sector subcontracting opportunities, provided that nothing contained in this clause shall prohibit or limit otherwise lawful efforts to remedy the effects of marketplace discrimination that has occurred or is occurring in the marketplace, such as those specified in Palm Beach County School Board Policy 6.143. Consultant understands and agrees that violation of this clause is a material breach of the Agreement and may result in contract termination, debarment, or other sanctions.

8.15 The Scope of Work for Geotechnical Engineering/Construction Materials Testing/Threshold Inspection Services on Continuing Contract shall be provided on a project specific basis as defined by the Owner in a project specific Short Form Agreement which is hereby incorporated herein.

3. All other terms and conditions of the Agreement shall remain in full force and effect.
