# Declaration of Appointed Office – Police Services Board, Library Board, Committee of Adjustment

# <u>Remarks</u>

Chief Ava Hall, Six Nations, brought greetings to the newly elected Council on behalf of Six Nations Council, noting the importance of our two communities working together through this new term.

# **Invocation**

Reverend Adrianne Robertson, Bethel Stone United Church, lead the attendees in an invocation, congratulating the elected and appointed members and challenging them to fulfill their office with a focus on servitude to their own values and beliefs, their communities, their ratepayers and their God.

#### **Inaugural Address**

Mayor Eddy made the following Inaugural Address:

"Rev. Robertson, Honourable Justice Kent, Past Wardens of Brant County, Past Councillors, Volunteers, Members of Council and Ladies and Gentlemen. Thank you for attending Council's inaugural session and sharing your interest in, and support of our municipal government. This is the level of government that supplies you with the most services but takes the least amount of your taxes!

This Council is the 6th elected Council to serve the citizens of the County of Brant since restructuring was affected January 1, 1999. That means we can celebrate our 16th Birthday on New Years Day, January 1 2015. There has been of course a continuance of governance by Councils of the County of Brant since 1852 when Brant was separated from the United Counties of Brant, Halton and Wentworth, previously called the District of Gore.

Previous inaugural sessions of the new Brant County Council have been held in Paris, Mt. Pleasant, St. George, Burford, and the Airport Community Hall, former Brantford Township. Tonight we are meeting in the new Burford Agricultural Hall, - a credit to the vision and determination of the donors, volunteers and citizens who willingly worked and contributed to its construction. Heart warming indeed.

The County of Brant is divided into 5 wards with 2 Council positions for each ward. Although our members are elected on a ward basis, they serve the entire population of the County and support the provision of services throughout. This support means the correction of serious problems, the constant upgrading and replacing, as well as the expansion, of County assets as required. The cooperation of members of Council results in effective government and progress for the municipality. The dedication of County staff to their various responsibilities, and for many during extremely adverse weather conditions, is acknowledged and deeply appreciated. Many of our citizens state their appreciation to members of Council. We also commend and thank the members of our emergency services for their dedication and responses as requested.

Our preferential location in Ontario has resulted in economic development and growth. We have developed successfully the Brant 403 Business Park on Highway 24 – Rest Acres Road at Bethel Road. Why is the location preferred – well because it is located on Main Street Ontario – Highway 403, and on the twinned track of the CNR mainline. We also have the Brantford Municipal Airport and we are outside the high-cost GTA. Wow. That should be enough and apparently it is because our 171 acres purchased for industry is 60% built and will soon be 75% occupied with new companies. Of course it has been costly to development. We purchased land designated for industrial development then proceeded to service it with complete municipal and other utilities. Then came MTO requirements including turning lanes onto and from Bethel Road to and from 403. This project was financed by borrowing from the Province's financing agency, OSIFA, at lower than market interest rates. Although the OSIFA financing is high, the Park will generate \$2 million of industrial taxes per year - taxes that will cover the financing costs of acquiring, servicing and developing the Park. Financial statements will be prepared to show these facts on an ongoing basis. It is also surprising to see additional industrial development in other parts of Brant as is now happening. An addendum to this report has been prepared to show what is happening, and the resulting number of jobs that will be available.

The County is also developing commercially and residentially, providing growth that results in the need for increases in services, facilities and staffing. Roads become crowded and so the recommendations that will be in our new Transportation study that will be soon completed and released are crucial to solving our road problems.

We will be faced with major road problems when 4 new gravel pits being planned begin extracting and exporting gravel. As most of the gravel is expected to leave Brant via Rest Acres Road and Highway 403, a new interchange on the 403 at Bishopsgate may be needed, especially with the traffic emanating from our 403 Business Park. The Ontario Ministry of Transportation will play a lead role in this proposal.

The recent sale of Brant County Power resulted in the former Council recently establishing a Legacy Fund which will attract higher rates of interest, grow the fund and also contribute funds to our annual budget as Brant County Power did in the past. The details of this transaction can be found on our new website.

Brant Municipal Enterprises, incorporated under the Municipal Act, was established by Council to replace Brant County Power Services Inc, incorporated under the Electricity Act, in the summer of 2013. It provides fibre optic services in the County and solar powered units in the County and Six Nations. These services followed the expansion of broadband internet services throughout Brant and Six Nations that was sponsored by the Ontario Ministry of Food and Rural Affairs. BME will also be responsible for calling and supervising the contract to replace streetlighting throughout Brant with LED lights to reduce the annual cost of streetlighting from \$500,000 to \$200,000, with a pay back in 8 years.

The Brant/Brantford Boundary request remains open. Our former Council made a revised offer to City Council with a request that negotiations take place but no action has taken place. I request Council to meet to become fully informed about the matter and previous negotiations and then decide the procedure to follow.

Although the current Ministry of Municipal Affairs has advised that the Province will not decide the matter, both the City and the County are affected by the Province's Places to Grow Legislation, and the Growth Plan for the Greater Golden Horseshoe, in fact we are a part of it.

Addition challenges and Issues for Council include:

- 1. Proposed construction of a new Brant County OPP headquarters
- 2. Expansion of Biggar's Lane Sanitary Landfill
- 3. A new zoning By-law to complement our present land use Official Plan. Staff have just circulated a draft plan for review.
- 4. Repair of the Cainsville Lagoon.
- 5. Construction of Paris Water Tower at the north end to serve present and future development.
- 6. Additional access to the Grand River for the ever increasing number of tourists who visit to travel it.

Relations with the Council of the City of Brantford are fine and we appreciate participating in the operation of several joint services with the City. Relations with the elected Council of Six Nations of the Grand River are fine and we appreciate the accomplishments achieved through the provisions of our joint Green Energy Accord that was approved a few years ago. The Accord is beneficial and working. We should continue to build on our fine relationships with our neighbours.

Brant County works cooperatively with other neighbours, as well through our membership in the South-Central Ontario Region Economic Development Group and the Western Ontario Wardens Caucus.

Tonight we acknowledge and express appreciation to all of our volunteers. The County of Brant is blessed with volunteers. The members of our Library Board, Council Advisory Committees and Local Boards serve without remuneration and offer valuable advice to Council. We thank you.

In addition, many service clubs operating in Brant stand out, and continue to help us with activities and financial donations to County facilities. The Scotland Optimists operates Scotland Park. The Mt. Pleasant Optimists operate the Mt. Pleasant Nature Park. Thank you. In addition, many service clubs contribute time, energy and money to help provide programs and facilities for our youth. Thank you. To all organizations and individuals that assist in any of so many ways, we need you, and we thank you.

Members of Council, the challenges are ours. The decisions that we make will propel this County progressively in to the future, or otherwise. By continuing to work together we will move forward and continue the progressive development of this municipality, and the continued protection of our arable farmland to ensure and continue this Brant as the outstanding area of the Province to live, work and play that it is!

This last note acknowledges the adverse weather conditions we have experienced during this last year but especially this last month that has been so disastrous on the grain harvest.

In closing, I commit to work with this Council and our staff to be a team player for the coming term".
