Chaplain's Corner

A Good Name

From "Our Daily Bread"
Author: David McCasland

Charles Ponzi's name will be forever associated with the financial fraud scheme he elevated to a way of life. After some minor financial crimes and brief times in jail, in early 1920 he began offering investors a 50 percent return on their money in 45 days and a 100 percent return in 90 days. Although it seemed too good to be true, the money poured in. Ponzi used money from new investors to pay prior investors and fund his lavish lifestyle. By the time his fraud was discovered in August 1920, investors had lost 20 million dollars and five banks had failed. Ponzi spent 3 years in prison, was later deported to Italy, and died penniless in 1949 at the age of 66.

The Old Testament book of Proverbs frequently contrasts the reputations of wise and foolish people: "The memory of the righteous is blessed, but the name of the wicked will rot....He who walks with integrity walks securely, but he who perverts his ways will become known" (Proverbs 10:7,9). Solomon sums it up by saying, "A good name is to be chosen rather than great riches, loving favor rather than silver and gold" (22:1). We seek a good name, not to honor ourselves but to glorify Christ our Lord whose name is above all names.

Report**
February 22, 2015

The Holiday Inn in Flint provided us with a nice meeting room for the February 22, 2015 State Council meeting. The meeting was chaired by V.P. Tim Driscoll (good job, Tim) as President John Riling and 2nd V.P. Bill Boudreau took an excused absence. Secretary Ray Essenmacher, Treasurer Dennis Cohoon and 16 delegates were also present.

Tim opened the meeting at 10:05 AM with the Pledge and a prayer. He then reported that he and his Chapter 310 have been keeping busy helping the veteran community. Chapter 310 assisted with a fundraiser to benefit "Never Forgotten" to the tune of \$16,000.00. It was brought up that chapters should check into the various charities they may donate to. It was also mentioned that only 16% of funds donated to "Wounded Warriors" (in financial trouble?) goes to assist veterans.

Ray reported that he has been emailing minutes and other veteran related messages to all known chapters and contacts. Ray also mentioned that he would be including his copy of the election report to the chapters. He would greatly appreciate it if all chapters would complete his copy and return it to him.

Dennis reviewed the financial report with the delegates. Lately the State Council has been just breaking even. The most activity he has been addressing relates to the Service Program.

Under announcements, Brian Bobek of Chapter 154 reported that his chapter would be moving soon to 18025 Fourteen Mile Road in Clinton Twp.. They are planning an April 25 open house dedication event. "The Wall that Heals" (a 154 sponsored project) will be at the Northville High School for a short visit beginning May 13, 2015. Brian's chapter has also gotten involved in hosting two softball games vs. an amputee wounded warrior group from Florida in August. Phil Smith of Dearborn Chapter 267 announced that his chapter will again be sponsoring their annual "Help A Vet" dinner/dance fundraiser (\$15.00) on April 18th.

Sandi Wilson then began a lengthy Agent Orange report. Endocrine Disruptors in the Environment, written by Sushil K. Khetan is a very technical book she suggested for those interested. She reported that Jack McManus, Chapter 310, Air Force 'Ranch Hand' participant and former Michigan State Council President has been very active traveling and advocating A.O. awareness and legislation. Sandi mentioned that both major political parties usually have monthly county meetings. It would be a good idea to attend some of those meetings and educate our local legislators on the medical issues affecting veterans and their families. As you may know Medicare is state funded and many veterans and/or their Michigan families may have to use that program for their health care. We may be able to convince them to pressure the

U.S. representatives to take corrective action. There are two A.O. legislative items, Toxic cause. Sandi also mentioned a Mr. Al Young, a VA contractor, who has been testifying against A.O. lawsuits. His truthfulness has been questioned numerous times. And lastly, Sandie reported that VA doctors in 1971 were aware of chromosome changes due to A.O. exposure. Really?

Bob Cummings reported that an A.O. rally/ride in Muskegon (a mini-Sturgis) on July 18 is planned. Check out AORIDERS.org for further information and additional child A.O. related links.

I then gave a brief constitution/convention report. I offered a state council related national amendment and received no support.

Tim reported on some veteran job opportunities he is aware of including the regional VA office and to check out USAJobs.gov for information. Tim also reported there were 1,634 POW/MIA from the Vietnam War. It was also reported that there has been 31,277 burials at Fort Custer National Cemetery and 24,357 burials at Great Lakes.

Ray submitted a lengthy PTSD/Substance Abuse report in the consent calendar. Early therapeutic treatment is best for veterans exhibiting signs of these health problems.

Dennis Cohoon, Region 5 Director spoke about the upcoming Convention and the Region 5 meeting in Springfield, IL from April 24-26, 2015. Now is also the time to submit an individual for a National VVA award.

Phil Smith, Service Office Director, then reviewed his written 6 page report. The VA has now gone paperless. Scanning is the new, improved way to submit and process claims for veterans. Phil recognized Melanie Thon (AVVA) as the newest accredited service officer. Melanie will assist in claims in SE Michigan. Beginning on March 24th the VA is forecasting completed claims within 125 - 130 days for (FDC) fully developed claims. The VA Choice Card was discussed. This card is only good if a veteran is more than 40 miles away from a VA health facility, unless the VA approves otherwise.

Brian Bobek, Veterans Treatment Court reported that the District Courts are becoming very busy while Circuit Courts are slowing down. Veterans need to realize the importance of accepting the terms through the VTC.

Betty Pike, AVVA President, reported that Cathy Driscoll has resigned her V. President position. Dennis Walling has stepped up to accept an appointment to finish her term.

After a brief discussion it was decided to hold the next State Council meeting on May 17, site to be determined. Meeting was adjourned at 1315 hours.

On February 9th at the Plymouth-Canton Vietnam Veterans of America Chapter 528 General Membership Meeting, we had special guests from the Detroit Veterans Center and the Kohl's Department Store on Ford Road in Canton. Special presentations were made to Lisa Grasso, Store Manager at Kohl's by Tyrone Chatman of the Detroit Veterans Center and John Fleming of Chapter 528. Lisa and her staff at Kohl's have been instrumental in helping the Chapter 528 in its annual Winter Clothing Drive to benefit the Detroit Veterans Center.

We successfully completed our 9th Annual Winter Clothing Drive. The Detroit Veterans Center is a vocational training and housing center for needy veterans and is located in Detroit.

The Chapter 528, VFW Post 6695 and the First United Methodist Church of Garden City collects used clothing during the first two weeks in December. Chapter 528 donates \$2,000 and various members go to the Kohl's Department Store on Ford Road in Canton to shop for new items. The Store Manager, Lisa Grasso and her sales staff are there to assist in identifying items needed and to help us purchase items that were on clearance, sale, etc. All totaled we spent \$2,000 to get clothing that had a retail value of little over \$10,000.
