# • Trick or Treating • 6 p.m. – 8 p.m.




# GARAGE SALE ORDINANCE

# SOLICITATION


Anyone going door-to-door soliciting products is required to obtain a Solicitation License from



the Village Clerk's Office. The only exception is if that person lives within three miles of Beverly Hills. If you want to know if someone has obtained a license, please contact the Public Safety Department (248) 540-3400 or the Village Clerk's Office (248) 646-6404. Solicitors who have complied with the Village's Solicitation Ordinance are issued a photo identification badge by the Village Clerk and instructed to wear it at all times while in the Village. Many times solicitors are unaware of the Village's requirement to visit the Clerk's Office before going doorto-door, but a phone call from you will help alert the police to visitors who need to obtain the proper okay to sell goods in the Village.

# APPLY FOR A PASSPORT AT THE VILLAGE OFFICE— APPOINTMENT REQUIRED

Anyone can apply for a passport at the Village Office. Hours of operation are Monday through Friday 8:00 a.m. to 4:00 p.m. Call (248) 646-6404

# **Appropriate Fees**

# U.S. Passport Book:

- \$110 Passport Application Fee (check payable to the U.S. Dept of State)-16 years of age or older (10 year passport). \$80 for 15 years of age or younger (5 year passport).
- \$25 Execution Fee for each application (check payable to the Village of Beverly Hills).

# U.S. Passport Card:

Valid for travel by land or sea between U.S. and Canada, Mexico, Bermuda and the Caribbean ONLY

- \$30 Passport Application Fee (check payable to the U.S. Dept of State)— 16 years of age or older (10 year passport). \$15 for 15 years of age or younger (5 year passport).
- \$25 Execution Fee for each application (check payable to the Village of Beverly Hills).

# RODENT CONTROL

Rodents, like all animals, seek food, water, and shelter. Whenever possible, they will look for refuge in our homes/yards and dine on our leftover food. Since rodents reproduce rapidly, it is essential to prevent the establishment of a nest and/or food source.



# How To Get Rid of Rats

Since rats need a place to live and food to eat, if you remove their shelter and food, rats can be eliminated. Starve them. Do not feed the birds and/or squirrels. Use metal trash cans or approved plastic with tight-fitting lids. Keep trash cans covered! Clean up fallen fruits and nuts from the ground. Remove pet food dishes and leftovers promptly after feeding. Trim back overgrown bushes and weeds. Clean up animal waste daily!

# Understanding Your New Water Bill

The Village of Beverly Hills—like many communities across the country—has revised the way water and sewer related costs are charged. This change will be reflected on your new water bill. Your water bill will now include the following charges:

### Water

The cost of water used during the billing period. The rate per unit reflects the wholesale cost billed to the Village from our supplier Southfield Oakland County Water Authority (SOCWA), based on annual estimated water usage for the Village. SOCWA rates are based on their costs from the Great Lakes Water Authority (GLWA), formerly DWSD, as well as SOCWA infrastructure and operating costs to receive, store, and deliver water to the Village. This cost reflects individual property owner usage.

# Sewage Disposal

The cost of sewage disposal continues to be a factor of water usage. The rate is based on costs billed to the Village by the Great Lakes Water Authority. The rate reflects the collection conveyance, and treatment of wastewater by the GLWA, and its operating, administrative, and debt service costs according to the new agreement with GLWA. This cost reflects individual property owner usage.

# **Debt Service**

This cost reflects current bond commitments by the Village for major infrastructure projects and will include any new bond commitments approved by the Village Council in the future.

# Infrastructure

This cost reflects annual estimated fixed costs for the Village. Fixed costs include meter reading, maintenance and improvement of the Village infrastructure for water and sewage. Infrastructure includes all of the water supply and sewage disposal lines, drains, pumps, and the associated

contracted services for monitoring, inspecting, and completing projects on the system. Annual infrastructure costs vary from year to year, however, annual costs average \$500,000. This cost is now divided equally among all Village residents and commercial users, regardless of individual water usage and sewage disposal, and is no longer added to the rate for water or sewage disposal.

# Minimum Usage Fee

A minimum water usage and sewage disposal fee of \$85 per quarter will be assessed for all accounts. Debt service and infrastructure fees will be equal to all residents.

Historically, the vast majority of your water rate has been established based primarily on water usage. The more you used, the more you paid. Throughout the GLWA system, as rates increased many homeowners decreased water usage. Water usage has also declined over the years due to homeowner conservation practices; installation of water saving appliances/toilets, etc., and even greater rain seasons. As volumes declined, the need arose to raise rates in order to meet expenses. A growing portion of these expenses are either fixed costs, such as debt payments and infrastructure repairs and upgrades—neither of which are significantly impacted by water volume used. As volumes continue to decrease and ex-

penses remain steady or increase, the cycle of increased rates and lower volumes became self-reinforcing and unsustainable.



Many other communities serviced by GLWA are experiencing these same issues. Recently, GLWA and SOCWA sought to stabilize revenues through the use of fixed charges. Fixed charges are a base charge to end users irrelevant of usage. As a result, the Village adopted the new methodology to separate water and sewage disposal rates from fixed costs.

# What are the actual rates for 2015/2016?

The rates for 2015/16 will be \$18.25/1000 cubic feet of water used and \$51.50/1000 cubic feet of sewage disposal. 1,000 cubic feet equals one unit.

# Is sewage disposal still tied to water usage?

Yes. There is no reasonably affordable or accurate monitoring method to measure sewage disposal by household/user. Therefore, the accepted method is to tie sewage usage to water usage within a community.

# If I use less water, will I pay less?

Yes, because fixed costs are separate, that charge will remain the same regardless of usage. However, the water and sewer disposal costs will continue to reflect actual usage. The less water you use, the lower those amounts will be.

# THREE THINGS YOU NEED TO KNOW ABOUT THE DO NOT CALL LIST

The first phone call in history happened on March 10, 1876, when Alexander Graham Bell rang up his assistant and said, "Mr. Watson - come here - I want to see you."

It wouldn't be surprising to learn that the second call in history took place later that evening, when a telemarketer rang up asking if a Mr. Bell lived at the residence and if he might want to buy some genuine snake oil. It seems like telemarketing and phones have gone together forever.

Surprisingly, the National Do Not Call Registry didn't come into being until 2004. Since then, it's had a rocky history, and many people still aren't quite sure how it works.

Even after a decade, you'll see myths online about what is and isn't blocked, whether or not cell phones are allowed, rumors that the FTC is about to release your number unless you act right away, etc. So I'm going to set the record straight and clear up the confusion.

# I. How to sign up for Do Not Call

Joining Do Not Call is actually very simple. You go to the website <a href="https://www.donotcall.gov/">https://www.donotcall.gov/</a> and enter the landline or cell phone number you want on the list. A quick email verification and you're done. You can also call 1-888-382-1222 from any phone you want on the list. That's all it takes.

Note: Fax numbers are governed under different regulations, so signing them up won't do anything.

Your number stays on the list until you ask for it to be removed or you give up the number.

Warning: You might receive a phone call from someone claiming to work at the Do Not Call Registry or Federal Trade Commission. They'll claim your number isn't listed on Do Not Call and offer to sign you up - you just have to provide some personal information. This is always a scam; just hang up.

# 2. What Do Not Call does and doesn't cover

The Do Not Call list keeps you off of forprofit business call lists, but it isn't immediate. Telemarketers update their lists periodically, so the FTC says it can take up to 31 days to take full effect.

Tip: If you receive an unexpected sales call after you've registered your number, and it has been on the list for 31 days, you can file a complaint. Just go to donotcall.gov or call 1-888-382-1222. Be prepared to provide the date of the call and the company's name or phone number.

On the other hand, political organizations, charities and survey takers are still permitted to call you. Businesses you've bought something from or made a payment to in the last 18 months also have a right to call. If you ask them not to, however, they must honor your request.

Sometimes on a call from a survey company they'll ask if they can make a follow-up call. If you agree, then an associated for -profit company can call you with a sales pitch.

Be careful when signing up for sweepstakes and free product offers. The fine print may grant your permission to receive telemarketing calls.

Under the rules, most businesses can't hit you with prerecorded telemarketing messages, also called robocalls, without your

written permission. Political and informational robocalls, such as those received from health care providers, banks and schools, are still allowed.

# 3. Cell phones and Do Not Call

Every year or so, a hoax burns like wildfire through email inboxes and social networks warning that all cell phone numbers are about to go public - register your mobile number right away!

The online rumor also points out that there's a deadline to register your cell phone, and - once registered - it only blocks your number for 5 years.

Strangely enough, the only thing the message gets right is the number to call (plus the fact that it only takes a few seconds to register).

For the record, mobile telephone numbers have never been in any danger of being made public or released to telemarketers. There has never been a deadline to register your cell phone. And you don't need to renew every five years (this was a rule for landlines that was axed in 2007).

In fact, even if you don't sign up your cell phone, the FTC says that unsolicited telemarketing calls or robocalls to cell phones are illegal. If you're getting unsolicited marketing calls, first ask the caller how they got your number and tell them you don't want to be contacted.

If they call back, file a complaint with the FTC at donotcall.gov or 1-888-382-1222. Again, you'll need to provide information about the date and time of the call, the caller's number and so forth.

Still, it is a good idea to register all your landline and wireless numbers, because if you do receive a telemarketing call, that's a good sign the person on the other end is a scammer.

Legitimate telemarketers play by the rules and don't want to risk a \$16,000 fine for disregarding a number on the list.



# OAK WILT By Judd Hart JH Hart Urban Forestry

Over the last few seasons, the number of confirmed cases of Oak Wilt has increased in the State of Michigan. Last year the disease was even found in parts of Oakland



County. Red Oak varieties are the most susceptible, as the disease will kill the tree within three (3) weeks time. White Oak varieties are more resistant and likely become carriers, but in some cases they go into decline and die within a few seasons.

Oak Wilt, a fungal pathogen very similar to Dutch Elm Disease, killed nearly all of the American and English Elm trees. Once the disease makes its way into the vascular system of an oak tree, it begins to slow and ultimately fatally stop the flow of water through the canopy. The vector, or carrier, of this fungal pathogen is the picnic beetle. If an oak tree is pruned during the growing season, or damaged in a storm event, the resulting wound(s) produce a sap which attracts the picnic beetle. If a beetle feeding on this sap is carrying the Oak Wilt fungus, it now has easy access to the vascular system though the wound.


The best way to help prevent oak trees from contracting Oak Wilt is to limit pruning to the dormant season (November – March). If an oak tree is damaged during a summer storm, it is imperative the wound be promptly treated with wound dressing to prevent sap flow. Taking precautions is essential, as there is not a cure for a tree infected with Oak Wilt. If your neighbors have

oak trees, these precautions should be followed as well because Oak Wilt can also be transmitted through root grafts. As stated, proper pruning will go a long way to protect our oaks, but there are preventive treatments available for Oak Wilt through Macro Trunk Injection. If you have a high valued oak you would like to protect, please feel free to contact me for a treatment quote.

# COLORFUL ALTERNATIVES FOR LEAF DISPOSAL

The beauty and splendor of autumn is generally diminished every year by the burdensome task of

raking leaves. There are several options for leaf disposal that are not only environmentally beneficial to your landscape, but can also



- I. Compost your leaves. Mix leaves with grass clippings and soil to create your compost pile. Compost can be added to your garden to enrich the soil and suppress plant diseases and parasites.
- 2. Chop or shred leaves with your mower and use them as mulch around ornamental plants, bushes and trees. Mulch reduces the need for watering and weeding.

Let leaves lie where they fall and mow them into the lawn.

- 3. Leaves eventually decompose and can improve soil. Shredded leaves carry up to 80% of the nutrients a tree extracts from the soil and air.
- 4. Bag extra leaves that are dry to save for use in your compost pile during spring and summer.

# **FALL FERTILIZING**

A lawn care option you may not have considered this fall is fertilizing. Fall is the best time to fertilize your lawn for quickly improving vigor and growing a healthier, greener lawn next spring.

When applying fertilizer this fall, consider:

Earth-friendly fertilizers. The overapplication of lawn fertilizers has been linked to water quality problems in the Rouge River watershed and local lakes. Earth-friendly fertilizers can reduce the problem by building turf density and health while minimizing the risk of excess nutrients such as phosphorus and nitrogen. Try fertilizers that have 50% or more slow release nitrogen and do not contain herbicides or weed-control.

# **DIRECT PAYMENT OF WATER BILLS**

# WHAT TO RECYCLE

# Food & Beverage Containers

\* Clean cardboard milk cartons, paper cups, drink and juice boxes.

# **Paper**

- \* All papers, paperback books and boxes can be mixed together in paper or plastic grocery bags. Just mix all paper items, including newspaper, magazines, catalogs, phone books, junk mail, office paper, computer paper, paperboard (cereal boxes, tissue boxes, shoe boxes, etc.) together in one bag and place in bin.
- \* Please do not recycle paper disposables such as napkins, tissues, plates, hand towels, binders, table covers, and placemats.

# Cardboard

- \* Non-wax coated with wavy corrugation in the middle.
- \* Discard any packing material, loose food or badly stained cardboard as trash.
- \* Large boxes or quantities: Fold or cut into 2' x 2' x 3' pieces and securely tie in bundles less than 40 lbs. Place under bin.

# Glass Bottles & Jars

- \* Clean
- \* Clear, green, brown and blue glass.
- \* Metal lids are OK. Labels are OK.
- \* No ceramics, mirrors, coffee cups, plates, window glass, broken glass or light bulbs.

### Plastic Jugs & Bottles

\* All plastic containers are accepted.

# Metal

- \* Metal food containers, beverage cans, pie tins.
- \* Metal clothes hangers, clean pots & pans, toasters, faucets, silverware, pipe, and other small metal objects that can fit into the recycling bin.
- \* Clean. Labels are OK.
- \* Clean aluminum trays and pie tins (no foil please).
- Place loose metal lids inside cans and bend so lids don't fall out.

# Paint & Metal Aerosol Cans

- Must be empty.
- Recycle metal lids.
- \* Do not try to flatten or remove the ends.
- \* Aerosols—do not puncture or remove ends.

# **Household Batteries**

- \* AA, AAA, C, D, 9 volt and rechargeable batteries.
- \* Place in a clear plastic bag and place inside recycle bin.
- \* NO automotive batteries (see "Household Hazardous Waste").

### Shredded Paper

Place in tied, see-through plastic bags inside bin.



# STOP! THIEF!

Be on the look out for scavengers taking recyclables from in front of your home, in particular, newspapers and metal. Taking recyclables is against the law in Beverly Hills. Your recyclables are revenue for the Village and help keep our sanitation costs down and reduce your taxes. If you see someone taking recyclables, please call Public Safety at (248) 540-3400.

# HOUSEHOLD HAZARDOUS WASTE—WALK INS WELCOME!

Appointments are no longer necessary.

The Special Household Hazardous Waste program offers residents a convenient and effective means of disposing of household waste products that require special handling, processing and disposal. Items such as paints, solvents, garden chemicals, household cleaners, automotive products, insulin syringes, fluorescent light bulbs, oils, and other household hazardous waste from homes, NOT businesses. Old medicines are accepted by SOCRRA through their Household Hazardous Waste Program by calling 248-288-5153 to schedule an appointment or log on to <a href="http://www.socrra.org/hhw\_appts.shtml">http://www.socrra.org/hhw\_appts.shtml</a>. To prepare old medicines, empty all medicines into an unmarked zip-top plastic bag.

The drop off center is located at 995 Coolidge Road (between 14 and 15 Mile Roads).

PLEASE REMEMBER THAT SOLID WASTE COLLECTION BEGINS AT 7:00 A.M. THE HAULER MAY CHANGE THE ROUTE ORDER AND COULD PICK UP YOUR STREET AS EARLY AS 7:00 A.M. IF YOUR ITEMS ARE NOT AT THE CURB BY 7:00 A.M., THEY WILL NOT BE PICKED UP UNTIL THE FOLLOWING WEEK.

# **REGULATIONS**

Collection begins at 7:00 a.m. sharp. Trash should be placed at the curb or roadside edge by 7:00 a.m. and not earlier than 5:00 p.m. the day preceding collec-



tion. The Village requires empty containers be removed by 7:00 a.m. the day following collection.

Trash and recycling bins should be placed on the front easement and not in the street, so as not to interfere with drivers and bicyclists.

# APPROVED GARBAGE, RUBBISH AND RECYCLING CONTAINERS

All garbage and rubbish must be placed in containers no larger than 35 gallons with handles, or in 2-mil plastic garbage bags. Containers & bags shall not weigh more than forty (40) lbs. Recyclables are to be placed in the green 18 gallon recycling bin, which should not weigh more than 40 lbs. Please separate trash and recyclables several feet apart.

# **BRUSH AND BRANCHES**

Branches less than 2" in diameter will not be collected with trash. They are considered compostable.



Branches that are larger than 2" in diameter are considered trash. Cut them into lengths not longer than 4 feet and tie them into bundles not exceeding 40 lbs. Logs or firewood must be cut to 2 foot lengths or less, bundled and set to the curb for trash collection.

# LARGE/IRREGULAR ITEMS

Large items such as TV's, sofas, mattresses and household furniture are picked up on your regular rubbish day. Very large items must be broken down into sections.

# **CARPETING**

Carpeting must be tied in bundles no wider than four (4) feet and not exceeding 40 lbs. Please do not put carpet out if rain is expected. If it gets wet, the contractor will not pick it up because of the weight.

# **LUMBER AND DEMOLITION MATERIAL**

Items such as wood (please remove nails), gutters, and other building materials must be cut into 3' lengths, tied in bundles and not exceed forty (40) pounds.

# **APPLIANCES (SPECIAL ITEMS)**

Large metal items such as refrigerators, stoves, washers, dryers, hot water tanks & lawn mowers (remove gas, oil & plug) are picked up on your regular trash day.



# ITEMS THE VILLAGE WILL NOT PICK UP

Explosives, hazardous waste, engines, broken concrete, bricks, wood with nails, contractor's materials, containers weighing more than 40 lbs., tires, and tree stumps will NOT be picked up and must be removed by the homeowner. Please call SOCRRA (248) 288-5150 for methods and services available for disposing of such material.

# **Non-Recyclables**

Your "trash" should be less than 25% of what leaves your home; 75% is recyclable. Residents needing another recycling bin can purchase one at the Village Office for \$12.00. Your trash should only include such things as:

 food waste and items with debris on them

- paper plates and cups, napkins, paper towels and tissues (all other tearable paper is recyclable)


