

We are now making plans for our 2012 Legacy Bank Calendar, and this time we are keeping it personal (so to speak).

In the past we've done a variety of themes with our photo calendar and we've actively sought submissions from all amateur photographers. This time the theme is "Favorite Photos" and we're inviting our "friends and family" to send in their favorites for possible submission in the calendar. Friends and Family include our customers, people who have submitted to our calendar in the past, those who appreciate the originality of our calendar; and of course the employees of Legacy Bank (really anyone). This call for entries is open to amateurs and professionals alike.

One other twist for 2012: in the past we have had a team of professional photographers who have judged the entries. This time the winning photos will be determined by popular vote. All qualifying entries* will be posted on a page on legacybank.com where people will be able to log in and vote for the photos they would like to see in the 2012 calendar.

Now, here are the fine details of how the contest will work:

Deadline for entries is 5:00pm on September 1, 2011. Entries after this date will not be accepted. Photos will be placed on legacybank.com to be voted on for entry into the calendar from September 5, 2011 through September 19, 2011. The winning entries will be displayed on legacybank.com after the allotted voting period. Each photographer may enter up to three photographs. Possible subject material for submitted photos may include but are not limited to architecture, points of interest, and public events.

*QUALIFYING ENTRIES: Legacy Bank reserves the right to decline entries that lack the necessary quality or appropriateness for this publication. Entries received that would necessitate a model release for photographed individuals will be disqualified. Photos should include the following specifications:

- Landscape (horizontal orientation) only
- Color or gray scale
- Digital files must be at least 3000 pixels wide by 2400 high (300 pixels per inch); tiff, jpeg, or eps format; CMYK or gray scale color mode; and submitted on a CD.

Submissions need to be of high enough clarity that they can be printed in an 8" x 10" format without greatly lessening the quality of the work. Prints will not be accepted. Photos may be edited for color or lighting balance, but no superimposed images will be accepted.

Entries submitted to Legacy Bank for this contest may be used at the bank's discretion for the duration of the contest and inclusion in the 2012 Legacy Bank calendar. Legacy Bank will not attempt to sell or distribute the photos for profit. Legacy Bank will not return entry CDs.

Complete all information on the attached entry form(s). If submitting multiple works in the same packet, title each in such a way to differentiate one from the other. Detach the form and submit it with your CD to:
