Priority given to adult students, followed by Seniors. All concurrent students must be at least 16 and be enrolled in an FUSD high school.
- 3. Completed Concurrent Student Permission Slip. (This form)

Concurrent enrollment BEGINS <u>Tuesday Aug 13, 2013</u>. Classes begin August 19th. Only FUSD Seniors may enroll on Aug 13th. FUSD concurrent enrollment is from 3:30pm-5:30pm Aug 13th, 14th, 15th or when seats are filled, whichever comes first.
