St Gemma's High School, Belfast, will close with effect from 31 August 2013 or as soon as possible thereafter.

Teaching Appointments Committee

The committee extended its thanks and that of Board of Governors to all the CASS officers who carry out the preparation for the Teaching Appointments Committee by supporting and advising governors in the interview for principals' and vice-principals' posts which are held in schools.

E58 Children and Young People's Services (CYPS) - Update

The assistant senior education officer (CYPS) spoke to a circulated paper which provided members with an update on children and young people's services and included:-

E59 Youth Service - Update

E60 Area Based Plan

The head of property services and the development planning unit manager spoke to a circulated draft area based plan for post-primary education.

The meeting noted the timescale for area plans as follows:-

- area plans should be made available from Thursday 5 July 2012;
- consultation period will run from 5 July until 26 October 2012; and
- a letter issued to all post primary schools before the end of term to highlight the launch date.

The meeting discussed the area based plan for post-primary education.

Board members expressed their concern that the current lack of representation of local councillors on the board has adversely affected the ability of the board to sufficiently reflect local community issues during the area planning process. The board considers that it would be inappropriate to make decisions and recommendations in the absence of participation by public representatives.

It was agreed that there would be consultation with political representatives regarding area based plans and they would be asked to provide their comments/responses in writing.

It was also agreed that the options in the post-primary plan for Orangefield High School would be redrafted to include the Grammar Schools (Wellington College and Grosvenor Grammar) within East Belfast and Castlereagh cluster of schools and that there would be consultation with SEELB.

Members thanked all the officers involved in drafting the area based plans and in gathering all of the information and data that had been included in these extensive pieces of work.

There being no further business the meeting ended at 4.14 pm.
