("AEBC"). I understand that the maximum limit on the total amount of Cash Withdrawals and/or Orders which I can obtain using this facility is Rs. 45,000 every fifteen days.

I declare and undertake that the American Express Corporate Card issued to me if used overseas shall be utilised strictly in accordance with the relevant exchange control regulations issued and as amended by the Reserve Bank of India (RBI) from time to time. In the event that I exceed my entitlements as per the Exchange Control Guidelines of the RBI, I undertake to bring the same immediately to the notice of AEBC in writing. Further, I also agree and understand that the onus of getting my passport endorsed/not endorsed for any charges incurred by me shall lie entirely on me. And in the event of my failure to comply with the prevailing Exchange Control Guidelines issued by RBI, I shall be liable for any action under the Foreign Exchange Management Act, 1999 as amended and be debarred from the Corporate Card facility either at AEBC's instance or by the RBI.
