

**FACTS****WHAT DOES AmeriChoice Federal Credit Union  
DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>■ <b>Social Security number and account balances</b></li> <li>■ <b>account history and payment history</b></li> <li>■ <b>credit history and checking account information</b></li> </ul>
<b>How?</b>	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons <b>AmeriChoice Federal Credit Union</b> chooses to share; and whether you can limit the sharing

**What we do**

<b>How does AmeriChoice FCU protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How does AmeriChoice FCU collect my personal information?</b>	We collect your personal information, for example when you: <ul style="list-style-type: none"> <li>■ <b>open an account or deposit money</b></li> <li>■ <b>pay your bills or apply for a loan</b></li> <li>■ <b>use your credit or debit card</b></li> </ul>
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only- <ul style="list-style-type: none"> <li>■ sharing for affiliates' everyday business purposes- information</li> <li>■ affiliates from using your information to market to you</li> <li>■ sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
<b>What happens when I limit sharing for an account I hold with someone else?</b>	<b>Your choice will apply to everyone on your account</b>

**Definitions**

<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>■ <b><i>AmeriChoice Federal Credit Union has no affiliates</i></b></li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>■ <b><i>Nonaffiliates we share with include: AON Consulting (Life Ring), Liberty Mutual, &amp; RCI (Selman and Co.)</i></b></li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products and services to you. <ul style="list-style-type: none"> <li>■ <b><i>AmeriChoice Federal Credit Union currently is not involved with any companies for joint marketing purposes</i></b></li> </ul>
