# Glen Elects New Board For 2016

At the Glen's Annual Meeting on November 4, 2015, the Board of Directors gained two new members.

Lee Henry was elected to the Board for a term of three years by a vote of 40% of the voting interest (95% of the votes cast). Bill Worsley was elected to the Board for a term of three years by a vote of 40% of the voting interest (95% of the votes cast).

In addition, the 2016 budget was approved by a vote of 39% of the voting interest (93% of the votes cast) and the minutes of the 2014 Annual Meeting were approved by a vote of 41% of the voting interest (97% of the votes cast).

Immediately following the Annual Meeting, the new Board held an organizational meeting to choose its new officers for 2016. They are:

## HOW TO PAY YOUR MONTHLY FEE



This month, Cardinal Management Group will be sending out the 2016 payment coupon books to co-owners who are not signed up for direct debit of their accounts. If you do not receive your coupon booklet by 12/11/15, please contact Cardinal at 703-569-5797. Co-owners who choose this method simply mail their coupon and check to Cardinal each month. The address is: Fairlington Glen Condominium, c/o Cardinal Management Group, P.O. Box 71209, Philadelphia, PA 19176-6209.

Co-owners can also choose to authorize Cardinal to directly debit their bank accounts for the payment of monthly fees by filling out the form on page 4 of this newsletter and mailing it to Cardinal at the address noted on the form with a voided check. This free automatic debit seems to be the easiest method for most in the Glen. As noted on the form, the direct debit authorization will remain in effect, and will be adjusted automatically by Cardinal each year to reflect changed fee levels, until you provide written notification of its termination.

**IMPORTANT:** Some co-owners may have automatic bill arrangements with their banks (without directly debiting their account by Cardinal). In this case, you should update these arrangements to reflect the new fee levels.

## SIDEWALK, STOOP REPAIRS UNDERWAY

At the Board's October 13 meeting, a contract was approved in the amount of \$8994.00 with Property Service Group (PSG) to perform stoop repairs on ten front porches in the Glen. PSG started this work during November and will continue this month. Work is being done in Courts 1, 2, 3, 4, 8, 9, 11, and 15.

Also, during the Board's November 10 meeting, a contract was approved in the amount of \$11,900 with contractor Ruben Arroyo for sidewalk repairs. Work began in November and will continue this month on seven different sidewalk sections in Courts 2, 5, 6, 7, and 9.

## GLEN CELEBRATES ITS 40th

On October 28, 1975, Fairlington Glen was officially born. It was on that night that CBI-Fairmac, the owner/developer at conversion, officially turned over control of the community to the first Glen Board during the Glen's first Annual Meeting.

Forty years later, the event was celebrated at this year's Annual Meeting with a 40th Anniversary cupcake cake that was served to those in attendance.

# CONGRATULATIONS TO COURT 12

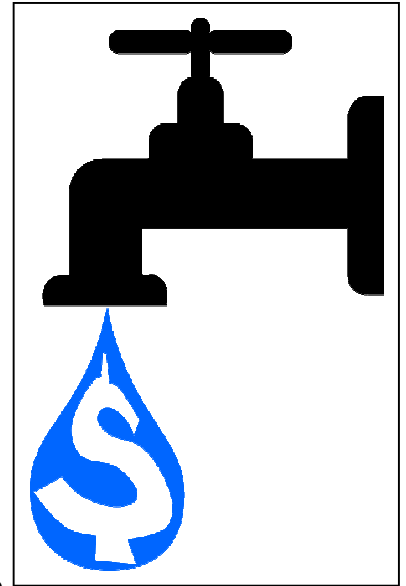
At Fairlington Glen's Annual Meeting on Wednesday, November 4, Court 12 was awarded the annual Most Improved Water Usage Award. Court Rep Bob Wilson accepted the award on behalf of the residents of his court.

Court 12's water usage in the four quarters ending August 2015 decreased 16.5% over the three previous years' average. The Board of Directors applauds this example of good citizenship within our community.

There are many easy steps to reduce water usage, and here are a few:

1. When buying new washing machines, dishwashers, or toilets buy those with ENERGY STAR ratings that use less water and save energy.
2. Run your dishwasher & washing machine only when filled to capacity.
3. Check your pipes and faucets for small leaks.
4. Turn off the tap while you shave or brush your teeth.

We appreciate anything you can do to help keep our water usage down.



# PLEASE PICK UP AFTER DOGS



All pet owners must abide by Glen policy and Arlington County regulations concerning pets, including required vaccinations and licensing. Both a rabies vaccination tag and a County dog license tag must be secured on a dog's collar at all times. A copy of Arlington County's regulations governing animal welfare may be obtained from the Department of Animal Control. All owners have sole legal and financial responsibility for the behavior of their pets.

Pet owners (or their agents) must clean up after their dogs at all times. Dog waste should be deposited with trash or in trash cans located in the Glen. Dog waste should never be dumped into a storm sewer because it then enters untreated into streams and rivers.

Pet owners must not allow their pets to make noise on a continuous or even frequent basis.

When taken outdoors, dogs are to be kept on a leash at all times. Dogs are not permitted to run at large except at designated "off-leash" dog exercise areas located in Arlington County. The closest dog exercise area to the Glen is at Utah Field.

## 10 Q's & A's

with

### Lee Henry

*Maybe you've seen their faces, but do you know their stories? Get to know your neighbors in the Glen each month through this feature we call the Glen 10.*

**1. Congratulations on your recent election to the Fairlington Glen Board of Directors. What motivated you to run for the Board?** “I would like to get a better understanding of how we spend our money, plan for ongoing projects, and respond to ad hoc demands that require an investment of our budget and the time of paid and volunteer resources.”

**2. You will serve as the Board's at-large member for 2016. What do you hope to accomplish?** “I hope to contribute to improving the processes we use in awarding and managing of business for ongoing improvements and repairs. I think that there might be additional ways to leverage our efforts to get the same or better results.”

**3. This isn't your first time volunteering in the Glen. How important is it for residents to volunteer their time and efforts for our community?** “Volunteering is both self-rewarding and is how we get things done. There are many projects in the Glen and a place for everyone to contribute. All these projects need both participants and leaders - choose the one that fits you. Little efforts and contributions add up to making the Glen function and a great place to live. I have learned from other folks and made some nice acquaintances and friends - it's me that has gained from volunteering.”

**4. Where are you from? What brought you to Arlington?** “I am originally from the Midwest and have spent some time in Europe. I had lived here in Northern Virginia before moving to Europe, and I liked the area. My spouse and I have found that the east coast, and Arlington in particular, offers us an interesting lifestyle, good employment opportunities, and an excellent place to raise a family.”

**5. Please tell us about your family. How long have you all lived in the Glen? What model do you own?** “My wife, son, and I have lived in the Glen for just over 16 years. We rented for about a year near the pool and decided that we wanted to purchase here because we found so much to like. We purchased an inside Clarendon in Court 1.”

**6. Why do you think this neighborhood is such a great place for raising a child?** “There are many great things about living here if you have a child: the playground where your child can play with other children and you can meet their parents; our pool, tennis, and basketball courts; great schools; easy access to DC for events and employment; closeness to airports for travel; supermarkets; easy medical support access; proximity to the community center(s); mass transit availability; shopping centers and restaurants so close; etc. This is a safe community with lots of people outside walking around, jogging, and playing in their yards. **7. What is one of your favorite stories or moments you can share about life in Fairlington?** “One Halloween night our family went to the court of one of our friends and had a blast - kids everywhere, an improvised outdoor movie screen, people mingling, sharing food, stories & pranks. Lots of smiles, noise, and fun for all.”

**8. Where did you go to school and what did you study?** “I had a bit of a circuitous path which included a local community college near Minneapolis followed by the University of Minnesota and then graduate school in Glendale, AZ. My first studies were in the sciences, and later I moved into business.”

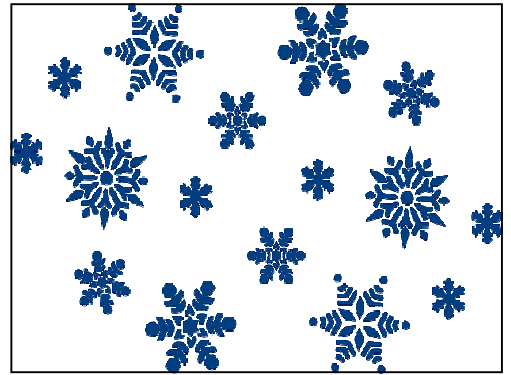

# WINTER IS COMING & WE'RE READY

Winter doesn't officially begin until December 22, but preparations for wintry weather began in the late summer/early fall here in the Glen.

Our on-site staff has already received a shipment of ice melt, which is stored in the maintenance shop along with the leftover bags from last winter. Ice melt products are used on sidewalks and walkways to residences. Our snow blower was recently serviced and is now ready for action. And the snow blade will be attached to the tractor to help clear sidewalks as soon as the forecast calls for wintry weather.



In October the Board unanimously approved a proposal from NVM Contractors for snow plowing/sanding services on an as-needed basis for our courtyard parking lots.

The association provides limited snow removal from parking areas and sidewalks. Contractors and on-site staff begin work as soon as is reasonably possible after significant snow accumulations. Keep in mind, though, the contractors and on-site staff don't live in the Glen. It has to be safe for them to travel here from their homes.

The Board encourages residents to contribute to snow removal in the areas around their units and parking lots.

## IMPORTANT TRASH REMINDERS

Please remember that there will be no trash pick up on Christmas and New Year's Day. Trash service will resume the day after each holiday.

With regards to recycling, our contractor Capitol Services has said no plastic bags are to be placed in the recycling bins. Plastics bags will clog the equipment at the recycling facility. Instead, recycle plastic grocery bags in receptacles available at most local grocery stores.

# MEETING TO ADDRESS HELICOPTER NOISE

Arlington County Board Member and Glen co-owner Libby Garvey reports that there will be a community meeting regarding helicopter noise on Wednesday, December 16 from 7:00 to 9:00pm in the County Board Room.

Confirmed attendees include representatives from the Federal Aviation Administration (FAA) Air Traffic Organization and the FAA Office of Environment and Energy. In addition, representatives from Joint Forces Headquarters Command, who operate some of the military helicopter traffic in the region, will be there as well.



Garvey said there was an overwhelming response to the general aviation community meeting she hosted in the summer. She encourages all residents with concerns about helicopter noise in Fairfax to attend this meeting. This will provide an important opportunity to understand the nature of helicopter operations in our region and to have questions answered.

For those unable to attend the meeting in person, it will be broadcast live through the County Board website and on Arlington TV.

# NOTES FROM THE ARLINGTON POLICE

Captain Adrienne Quigley, Third District Commander of the Arlington County Police Department (ACPD) spoke to the community on November 9 at the Fairlington Citizens Association (FCA) monthly meeting.

Captain Quigley said, "Fairlington is a very safe community." She said that larcenies from autos (LFA's) and stolen cars have been the biggest crimes in the community for the last two decades. She emphasized that since July, there have been no LFA's in Fairlington due to forced entries. So you are reminded to always lock your car doors and always keep any items in the car out of sight.



Captain Quigley also noted that several arson cases in the immediate area are still being actively investigated.

## BEWARE FALSE CORRESPONDENCE

According to a news release from Arlington County, many County homeowners have received false real estate tax correspondence. The letters, reportedly signed by Jud Allen of Express Homebuyers, falsely claim that owners owe real estate taxes and that the County may take their homes away due to delinquent taxes.

Arlington County Treasurer Carla de la Pava said, "I want to assure County homeowners that, unless you have heard directly from the Arlington County Treasurer, you do not owe delinquent real estate taxes and there is no risk of the County taking or selling your home."

## SHIRLINGTON MOVIE THEATERS RE-OPEN



After extensive renovations costing reportedly several million dollars, the AMC Shirlington movie theaters re-opened on November 17.

Improvements include new screens & a new sound system, new carpeting & paint, new bathrooms on the main level, a new concession stand, and comfortable red leather reclining seats.

The theaters, located at 2772 S. Randolph Street in Shirlington, had not been renovated since Federal Realty Investment Trust acquired the property in 1995.
