Conditions

As applicable to the type of application

All passes

General entry conditions of the Swim Centres applies to all patrons.

Passes/cards remain the property of Lake Macquarie City Council (LMCC) and it's Swim Centres. Passes/cards will be withheld from un-financial passholders. LMCC and it's Swim Centres, reserves the right to refuse or cancel any program and entry passes/cards of any person in its absolute discretion. All passes/cards can only be used by the registered person/s to the pass/card for the paid program or entry type. Passes/cards are not transferable. A fee is applicable for lost/replacement passes/cards.

Learn to Swim program

Bookings are required. Class lessons must be booked and paid upfront for a full term. Terms are based on school terms which may vary in duration. Centre managers have discretion to offer shorter term block payments in certain circumstances. The fees for two or more lessons per week applies to the same person enrolled in the program. Cancellations - no refund for cancellations for failure to attend. No make up lesson for cancellations less than four (4) hours notice. Managers have discretion in exceptional circumstances. Cancellations greater than four (4) hours notice may receive a make up lesson if a vacancy exists within the same term or within two (2) weeks of the following term. A make up lesson or credit will be provided for lessons cancelled by the centre due to unforseen circumstances e.g. weather conditions. Program spectators (parents/guardians/siblings) who are spectating only are fee.

Squad program

Bookings are required. Squad sessions are to be paid upfront in monthly blocks based on the number of sessions booked per week, per the applicable rate, and the number of weeks/session in the calendar month. The multiple sessions per week rates apply to the same person enrolled in the program. Cancellations - no refund for cancellations or failure to attend. No make up session will be provided for cancellations with less than four (4) hours notice. Managers have discretion in exceptional circumstances. Cancellations greater than four (4) hours notice may receive a make up session if a vacancy exists within the same month or within two (2) weeks of the following month. A make up session or credit will be provided for sessions cancelled by the centre due to unforeseen circumstances e.g. weather conditions. Program spectators (parents/guardians/siblings) who are spectating only are free.

Fitness program multi-visit pass

Bookings are recommended for all fitness programs. Notice of inability to attend is appreciated and no fee is charged for cancellation of bookings. Fitness programs include entry for a recreational swim before and/or after the fitness class for the program participant only. Multi-visit fitness passes may be purchased for convenience in any quantity at the applicable per session fee multiplied by the quantity purchased. Each quantity purchased is valid for 12 months from the date of purchase. The Fitness Concession rate applies to children aged 5 to 17 years, and concession cardholders of: Seniors Card, Health Care, Commonwealth Seniors Health Care, Pensioners and unemployed persons. Fitness passes are not transferrable and can only be used by the registered pass/card holder.

Multi-visit entry passes

Multi-visit entry passes may be purchased and used at any LMCC operated swim centre: Charlestown, Swansea, Speers Point, West Wallsend. These passes may be also be used at the Contractor operated swim centres: Toronto and Morisset. Multi-visit entry passes are valid for 12 months from date of purchase. Multi-visit entry passes are for general entry only and do not include programs. Multi-visit entry passes are not transferable. Multi-visit entry passes are valid for use by the person/s registered to the pass/card when purchased. For example, adult partners may share an Adult card, children of the same family may share a Concession card. One (1) visit per person is deducted from the pass/card for each person entering the swim centre. The Family category is valid for use by the family members registered to the pass/card when purchased. Family entitles two (2) adults/partners and their dependent children under 18 years as listed on their Medicare card or similar evidence of family unit. Each occasion the pass/card is used equals one family visit deducted from the card. Concession applies to children aged 5 to 17 years, and concession card. Pensioner Card, Health Care, Commonwealth Seniors Health Care, and unemployed person, where not entitled to a Pensioner Concession Card. Pensioner applies to Pensioner Concession cardholders including; age pension, disability support, sole parents, and their dependents under the age of 18.

Term membership entry passes

Memberships are available for purchase and use at LMCC operated swim centres: Charlestown, Swansea, Speers Point and West Wallsend. Memberships may be accepted at the Contractor operated swim centres: Toronto and Morisset; centre manager's discretion applies. Memberships entitle the registered individual membership cardholder to unlimited general entry for one (1) month, commencing on the date of purchase and expiring on the same date of the next month. The membership pass/card cannot be used or shared by any other person/s. Concession applies to children aged 5 to 17 years, and concession cardholders of: Seniors Card, Health Care, Commonwealth Seniors Health Care, and

unemployed person, where not entitled to a Pensioner Concession Cardonoiders of: Seniors Card, Health Care, Commonwealth Seniors Health Care, and unemployed person, where not entitled to a Pensioner Concession Card.

Pensioner applies to Pensioner Concession cardholders including; age pension, disability support, sole parents, and their dependents under the age of 18. The Family membership category entitles the registered family members of the membership to unlimited general entry for one (1) month, commencing on the date of purchase and expiring on the same date of the next month. Family means two (2) adults (parents/partners) and their dependent children under age 18 as listed on their Medicare card or similar evidence of family unit. The membership pass/card cannot be used or shared by any other person/s not registered to the pass/card. Memberships are not transferable. Memberships are for general entry only and do not include programs. Memberships can be renewed monthly for the applicable fee.
