Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink and Dennis Wright. Supervisor Mark Sybesma was not present for the beginning of the meeting.
- **09-09-28 2** Minutes of the meeting held on September 22, 2009, were submitted and the Vice-Chairman declared them approved.

"Shall the Board of Directors of Northwest Iowa Community College, Merged Area IV, in the Counties of Cherokee, Lyon, O'Brien, Osceola, Sioux,, Clay, Dickinson, and Plymouth, State of Iowa, cause to continue to be levied a tax not to exceed six cents per thousand dollars (6¢ per \$1,000) of assessed value in any one year for an additional period of ten (10) consecutive fiscal years beginning with the tax levy payable in the fiscal year ending June 30, 2011 for any one or more of the following purposes: for the purpose of program sharing between community colleges or for the purchase of instructional equipment; or for such other purposes as authorized by law, as provided in Chapter 260C, Section 28 of the Code of Iowa, as amended?"

09-09-28 5 Shane Walter, Community Services Director

- Distributed the September MH/DD Expenditure Report.
- Explained that many situations can affect the MH/DD Budget. The bottom line of the budget is healthy, but circumstances can change that status quickly.
- As this was the date and 10:00 a.m. the time set for a Public Hearing on an Iowa Department of Natural Resources Construction Permit Application for James Vander Waal Dairy proposing the addition of one dairy free-stall barn and three deep bedded confinement barns in Section 2 of Lincoln Township, said hearing was held according to law. Shane Walter, Zoning Administrator noted that a favorable Matrix score was received. No comments either written or oral were received. No one was present for this discussion. The Chairman closed the hearing. Motion by Wright and supported by Bloemendaal to recommend approval of the aforementioned permit to the Department of Natural Resources. Motion carried, unanimous in favor.
- Motion by Degen and supported by Kleinwolterink to support the application by Hope Haven for a community block grant. Motion carried, unanimous in favor.
