It was agreed to send a letter of congratulations to the Club.

Mayor Cole said that he would also be organising a photo call in Crossmaglen with the Team and Club Manager and Slieve Gullion Councillors to acknowledge their great achievement.

Councillor McCreesh and Councillor O'Hare also asked to be associated with the congratulations to Crossmaglen Rangers.

Read: Correspondence dated 24 September 2007 from the Health Promotion Agency for Northern Ireland giving details of the Fourth All-Ireland Health Promoting Hospitals Conference 2007 to be held from 23 to 24 October 2007 in the Armagh City Hotel at a cost of £166 including conference dinner.

It was unanimously agreed to appoint Councillor McArdle and Councillor M Murphy to attend the above conference.

It was unanimously agreed to appoint Mayor Cole and Councillor J O'Hare to attend this event.

#### **NOTICES OF MOTION**

M/287/2007:- NOTICE OF MOTION (REF: M/53)

The following Notice of Motion, listed on the Agenda in Councillor Curran's name, was withdrawn prior to consideration.

"This Council agrees that the recent band competition held in Newry has highlighted the need for this type of event to be held in a more suitable location".

M/288/2007:- NOTICE OF MOTION (REF: M/53)

The following Notice of Motion came forward for consideration in the names of Councillors J Feehan, B Curran, D Kennedy and J Patterson:-

"This Council notes that the manufacturing base in Northern Ireland has been in steady decline. This Council further notes that an increase in industrial rates of over 25% will be a grave threat to our manufacturing base. Council resolves to write to the Minister for Finance and Personnel urging a freeze at 25%".

Councillor Curran said he wished to withdraw his name from this Motion.

Councillor Feehan formally proposed the Motion and said that many people had worked very hard to bring unemployment down to a 3% level and industrial experts were warning that if there was a increase in industrial rates it could lead to job losses and the closure of businesses.

Councillor O'Hare formally seconded the Motion and said a number of elected representatives had attended a Meeting with manufacturing businesses in the Newry and Mourne area. The message from that Meeting was that it was imperative that this Council gets behind business people who had kept people in employment through very hard times and whose efforts have ensured that this area was kept alive.

Councillor McCreesh said that his understanding was that there was presently no rates on manufacturing industries.

Councillor Curran said that Sinn Fein were awaiting the outcome of a current Review into industrial rates, and until the outcome of that Review was known, Sinn Fein could not support the Motion.

Councillor Cole said a Meeting had been held with a local business company in Newry and out of that Meeting it had been proposed that this Motion be sent through to all Councils.

Councillor McGinn said the Manufacturing Rate Review being carried out by the Economic Research Institute must take into account the need to protect jobs and he said protest groups had kept this issue high on the agenda. He said it was essential that

the Northern Ireland Assembly must take into account any seismic increase in rates would have on jobs and they had to get the balance right.

Councillor McGinn said he was not prepared to put forward in writing any figure as to what industrial rates should be set at and said this was only one aspect of a much wider problem which required reform.

Councillor Casey said in his view it had not yet been established that there would be manufacturing rates set and the Council's position should be that the current position of no rating for manufacturing should be retained.

Councillor Feehan said all parties had attended the local business Meeting and all parties had agreed with the Motion.

Following further discussion, the Motion was put to a vote and it was noted that Councillor Curran's name had been withdrawn from the Motion.

Councillor Ruane proposed and Councillor Carr seconded that the above report and recommendations be approved.

Councillor McKevitt referred to recommendation No 3 i.e. that 3 bilingual "Welcome to Rostrevor" signs and 2 bilingual "Welcome to Ballyholland" signs be erected. She said she would like the signs in Ballyholland to read "Welcome to Ballyholland and District".

It was agreed therefore that the 2 bilingual signs to be erected in Ballyholland should read "Welcome to Ballyholland and District".

M/293/2007:- REQUEST FOR ACCESS ROAD AT ROSTREVOR MUNICIPAL CEMETRY (REF: F/3/4 PH/14/1)

Read: Report of Crotlieve Councillors Meeting held with Representatives from St Bronagh's GAA Club on Thursday 27 September 2007 to consider a request from the Club for the Council to grant an access road along the boundary of the field adjacent to the Council's Municipal Cemetery at Kilbroney Road, Rostrevor (copy circulated).

The report recommended the following:-

- 1. Council Officials liase with representatives from Roads Service in relation to the proposed access road through Council owned land on Kilbroney Road, Rostrevor i.e. the Municipal Cemetery Site, as a matter of urgency.
- 2. Council consider, in principle, to support the request from St Bronagh's GAA Club, Rostrevor for a Right of Way across Council owned land at Kilbroney Road to access lands currently for sale for a proposed playing field development and to issue a letter of support to the Club to enable them to bid on this land. The Council's support for the request of the Right of Way would be subject to valuation, with the Club to be responsible for all development costs and for obtaining all necessary statutory approvals. (copy circulated).

Read: Correspondence from Mr E McManus, Deputy Director of Technical and Leisure Services, referring to the Meeting held on Thursday 27 September 2007 and stating that he had contacted Roads Service who had advised him on a "Without Prejudice" basis that it was likely that Roads Services requirements in relation to visibility sight splays would be 4.5m by 90m and it was likely that Roads Service would require a footpath to extend from the last section of the footpath on the Kilbroney Road up to the frontage of the access road. Mr McManus said the maps submitted by St Bronagh's Club showed the proposed access at the Rostrevor end of the Council's land but it was unlikely that the minimum required sights splays in the Rostrevor direction could be provided without the Club reaching agreement with the land owner immediately adjacent. He said the frontage of the entire Council land was approximately 200m in length and it would therefore be possible to achieve the required sites if the proposed access was located approximately centrally on the Council's frontage but this would effectively split the Council's field in two (copy circulated).

Councillor M Murphy said this possibility was discussed at the Site Meeting and Councillors had agreed that if necessary the entrance could be moved to the middle of

the Council's boundary and that the access road could then keep to the right-hand boundary around the inside of the municipal cemetery.

On the proposal of Councillor Murphy, seconded by Councillor O'Hare it was agreed to approve the report of a Meeting held on Thursday 27 September 2007 and the recommendations.

On the proposal of Councillor Stokes, seconded by Councillor W Burns it was agreed to:

- (a) accept the legal advice from McShane & Company Solicitors in relation to this matter.
- (b) Confirm that in light of the legal advices received, the Council decision of 20/08/07 stands and is now to be actioned.

In response to Councillor Carr, Mr McCall confirmed the Council may rescind any resolution it passed in accordance with Standing Orders 10 or 20.

#### **CHAIRMAN'S BUSINESS**

## M/301/2007:- PROVISION OF AMBULANCE COVER IN THE SOUTH ARMAGH AREA (REF: G/13/3)

Councillor T Murphy referred to correspondence received from the NI Ambulance Service in relation to concerns raised by the Council regarding special arrangements between the NI Fire Service and the NI Ambulance Service.

On the proposal of Councillor T Murphy, seconded by Councillor T Hearty it was agreed to write to the Chief Executive of NI Ambulance Service advising the Council was concerned that at a public Meeting held on Tuesday 5 December 2006 in Crossmaglen and in subsequent correspondence received from NIAS, assurances were given that special arrangements would be put in place in Armagh in response to motor vehicle accidents, given that it was not possible for ambulances to meet the 8 minute response time for emergency calls.

The Council to point out to the Chief Executive of NIAS that he had said an automated paging system would be introduced as a supplementary measure to create a greater degree of assurance and also the possibility of a first responder scheme in South Armagh would be looked into.

It was further agreed to advise the Chief Executive of NIAS that in the opinion of the Council, no special arrangements have been put in place specific to South Armagh,

which are not in place throughout the whole of Northern Ireland and the Council are now requesting an urgent Meeting with him to discuss issues relating to the provision of ambulance cover in the South Armagh area and the outstanding issues that have yet to be addressed

### M/302/2007:- PUBLIC FISHING GROUND – BELFAST LOUGH (REF: G/1)

On the proposal of Councillor Connolly seconded by Councillor Williamson it was agreed to write to the Department of Agriculture and Rural Development regarding an application by a Dutch Company to designate the fishing grounds at Belfast Lough as private fishing grounds rather than public as at present.

It was agreed to advise the Department that the Council was concerned that if this application was successful it would have an adverse impact on fishermen in our District, particularly in the Kilkeel area, where up to 15 fishermen could be affected and the Council's opposition to this proposal be recorded.

### M/303/2007:- CONGRATULATIONS (REF: M/23)

At the request of Councillor Hearty it was agreed to send a letter of congratulations to the Parish Priest in Glassdrumman and the Curate on the organisation of a series of events to mark the 75<sup>th</sup> Anniversary of the building of the Chapel at Glassdrumman and the beautiful mass in St. Brigid's at which Bishop Clifford officiated.

Councillor Donnelly asked to be associated with these remarks.

M/304/2007:- COOKERY DEMONSTRATION

- NEWRY SPORTS CENTRE

- WEDNESDAY 3 OCTOBER 2007

On the proposal of Councillor Stokes seconded by Councillor McKevitt it was agreed the Council make a contribution towards the hire cost of Newry Sports Centre for a Cookery Demonstration to be held on Wednesday 3 October 2007, which was being organised to raise funds for a nominated charity.

At the request of Councillor McGinn it was agreed to send a letter of sympathy to Wicklow Fire Authority on the tragic death of the 2 firefighters which had occurred as they attempted to put out a warehouse fire in Bray.

Councillor McGinn said that a lot of potential harm and injury could result from the misuse of fire and he appealed to people to be careful, particularly in the run up to Halloween.
