Councillor Rogers said he wished to tender his resignation as a Councillor with effect from Thursday 5 April 2012. Councillor William Burns also asked to be associated with all the previous remarks and said he had enjoyed working with Sean. He said Sean was a

Councillor who represented a rural area and he understood the issues and needs of rural people.

Councillor Patterson also extended his best wishes to Sean and said he had always found him to be very likeable and approachable. He said he was great listener and this was very important in a politician and he wished him well in his future role.

Councillor McKee said when he had been elected as a Councillor he had found a friend in Sean Rogers. He said Sean was a good man and he wished him well in his future. He had attended all Meetings in the Mourne area and was very interested in the Mourne Young Forum.

Councillor Moffett also wished Sean well in his future role in the Assembly. He said Sean was a very decent fella and he hoped he enjoyed his new career in Stormont. He welcomed Brian Quinn as the new Councillor for the Mourne area.

Councillor Reilly said he was sad to see Sean going as he was an excellent person, very thoughtful and a man of great intellect. He said he had great management ability and he would do well in the Assembly. He also welcomed Brian as the new Mourne area Councillor.

Councillor O'Hare said he had known Sean Rogers for a very long time and had always found him to be a gentleman. He said Stormont needed MLA's like Sean and he wished him all the best in his new career. He also welcomed Brian as a new Councillor.
