#### DD/491/2009:- ELECTION OF CHAIRMAN FOR 2009/2010 PERIOD

Councillor McCreesh proposed and Councillor McDonald seconded the election of Councillor T Hearty as Chairman of the District Development Committee for the 2009/2010 period.

There being no further nominations it was agreed to appoint Councillor T Hearty as the Chairman of the District Development Committee for the 2009/2010 period.

#### DD/492/2009:- ELECTION OF VICE CHAIRMAN FOR THE 2009/2010 PERIOD

Councillor Kennedy proposed and Councillor Oliver seconded the appointment of Councillor I Hanna as Vice Chairman of the District Development Committee for the 2009/2010.

There being no further nominations Councillor Hanna was appointed Vice Chairman of the District Development Committee for the 2009/2010 period.

Councillor Hearty took the Chair at this point in the meeting.

#### DD/493/2009:- MINUTES

On the proposal of Councillor Patterson seconded by Councillor I Hanna, Minutes of the District Development Committee Meeting held on Monday 18 May 2009 were adopted as a true and accurate record, same having been circulated.

#### **MATTERS ARISING**

#### Pairc Esler Concert Event – Sunday 30 August 2009.

Councillor Casey referred to the planned concert at Pairc Esler on Sunday 30 August 2009 and said he had now being advised that this event may not take place. He said he believed the organisation of the event was now at an advanced stage and if it was not to proceed the Council may lose money. He said that at the Southern Cluster Peace III Partnership Meeting held on Thursday 18 June 2009 members of the Committee were opposed to the event being held on a Sunday on religious grounds.

Councillor Feehan expressed his disappointment that the Pairc Esler event may not proceed on religious grounds. He said as contracts have already been signed, monies will have to be paid out.

Councillor W Burns said it was his view that Peace III monies were to be spent by the 4 cluster councils and he was not happy that the Council had gone and allocated monies. He said the concert event was based on reconciliation between the two communities and Sunday would not suit the vast majority of the community he represented.

Councillor McGinn said if the concert was now not going to take place then the rationale for the post of Events Officer would have to be re-visited.

Councillor Kennedy said care had been taken to select a venue and equal care should have been taken to select a date. He said there was a failure to recognise the sensitivities of holding such an event on a Sunday.

Councillor Casey said he accepted the fact that people kept the Lord 's Day but over the years, in his view this seemed to become more relaxed.

It was agreed to bring a report back to the Council at the Technical/Environmental Services Committee to be held on Monday 29 June 2009.

#### Summer Schemes

At the request of Councillor Burns it was agreed the appropriate official furnish him with details of the summer scheme budget and when they will be advertised.

#### Play area at Mourne Esplanade

Councillor Reilly advised that he had received a number of complaints about the condition of the play area at Mourne Esplanade which was strewn with broken glass and rubbish.

It was agreed to refer this matter to the Technical/Leisure Services Department for attention.
