VOTING REQUIREMENTS

To have a vote at the Congress Meeting - must have a 2013 USTA Team Membership (\$100), be listed as a coach on the Team Membership Form, have a 2013 Coach Membership (\$20), have had at least three (3) active athlete members during the previous competition year, and have had concurrent USTA Team Memberships since the 2010-11 competition season or have a 2013 Associate Membership pre-approved by the USTA Executive Board. All memberships must be applied for by September 1, 2012. Membership Forms are enclosed. The coach who votes at Congress must have a paid USTA Membership also.

The USTA Congress Meeting, which is held on the last day of Congress (Sunday, September 30, 2012), is when the discussions, voting, rule changes, elections, clarifications, etc. that affect your club and athletes take place. This meeting is free and open to all USTA members. Everyone has a voice and all current members who meet the requirements listed above have a vote. Even if you are only attending Sunday's Congress meeting, please return your registration form for planning purposes.

RE-CERTIFICATION.

- 1. Tests. Testing for everyone as listed below. @ \$25 per discipline unless taken at Congress for \$10 (this year will be tumbling only). Closed book tests may be taken at USTA Congress or at any of the New Judge's Courses.
 - ♦ 1st year judges (going into 2nd year) Closed Book Test
 - ♦ 2nd year judges (going into 3rd year) Closed Book Test
 - ♦ 3rd year judges (going into 4th year) Closed Book Test
 - ♦ 4+ year judges (going into 5th year and over) Closed Book Test

Deadline to receive, take, and post tests is December 15. Re-certification Tests will NOT be mailed until paid for. Contact our N.T.J.C. Judging Coordinator, Cynthia Willoughby if you have any questions or if you do not receive your test(s) in the mail after you have sent payment.
