FCRA Holds Its First Freestanding Seminar With the Florida Bar

In an effort to help Florida reporters — as well as Florida Bar members and paralegals — get their CEU/CLE credits in before the end of the year, the Florida Court Reporters Association sponsored “Filing Appeals 101,” a three-hour seminar in Ocala, on September 26.

This seminar was pre-approved through NCRA and FCRA for .03 CEUs, as well as provided 3.5 General CLEs and 1 Ethics CLE for attorneys and 2 CLEs for certified paralegals (FRPs) through the Florida Bar. FCRA members and Florida Bar members were charged \$25 and nonmembers were charged \$40. The pre-approval meant that there were no conversion fees to NCRA or the Florida Bar for the attendees to submit their CEUs or CLEs.

The seminar speakers were David G. Mengers, Esquire, and Kelly Owen McCall, RPR, FPR. The seminar covered the filing of appeals and what is required from both the trial attorney and court reporter, as well as discussion on how the actual

procedures differ around the state. The attendees consisted of reporters, court reporter managers, attorneys and paralegals from Miami to Tallahassee.

As many of our members already know, FCRA is making great strides in strengthening our working relationship with the Florida Bar and judiciary. This was not only a relevant topic for reporters and a very affordable way to pick up some last-minute CEUs, but it was also a great opportunity for our members to interact with attorneys and paralegals regarding how important following the state and local rules are and the importance of the attorneys and reporter working together through the initial appellate process.

I sincerely hope that FCRA can do this on an annual basis. For the money, with the pre-approval to NCRA and no conversion fees involved, even for non-FCRA members, this seminar provided education on a relevant topic that many Florida reporters desperately need an update on. Yay us!

Emily Mann Distinguished Service Award

The Emily Mann Distinguished Service Award shall be bestowed by FCRA upon a person who possesses exceptional qualifications and experience in the field of court reporting, while contributing in a meritorious manner to the welfare of FCRA; and has served the Association in at least two (2) of the following categories:

- (1) Served the Association with active participation on committees and/or on the Board of Directors of the state association.
- (2) Contributed to the profession in areas of teaching, editing of publications or other contributions which have been designed for the advancement of court reporting.
- (3) Contributed important books, papers or other written material dealing with the profession.
- (4) Contributed seminars for the state association for members, such seminars having received the approval of NCRA for continuing education points.
- (5) Aided in the advancement of the profession by working in liaison with The Bar, the media, judicial groups, and/or educational institutions.

Student Corner

All of us have a back story as to how we became aware of and then went into the court reporting profession. For some of us, we knew a court reporter, others saw it showcased in a career day, etc. Some stories are more mundane, some are quirky, and some are sheer happenstance. Few are as dramatic and inspiring as Kristi's. — *Robin Merker*

THAT NIGHT

April 23, 1997, I headed out for the evening with a good friend of mine. Toward the end of the evening, after my friend had had a few cocktails, she got in a fight with her boyfriend and insisted on driving home as she needed to see him to work things out. I was sober and thought I should drive and I pleaded with her to give me the keys. She refused.

During that evening, I had run into a friend of mine who just so happened to be an off-duty police officer out with a few of his buddies. He walked me to the car and tried to help me reason with my friend to let me drive her home. After 20 minutes or so, he suggested we let her go – she only lived a few blocks from there. We'd follow her and do our best to keep her (and anyone else on the road) safe. I agreed and got into his truck and they drove me back to her house.

We pulled in the driveway. I said my good-byes. As I turned to open the door, I heard the pop of the gun. I felt an immediate burning, I couldn't breathe, and what I can only describe as a sensation of almost floating. I knew immediately I was shot. Once I caught my breath, the first thing I thought was, I can't die tonight.

Believe it or not, I was calm. I was trying not to panic. I turned to the driver of the truck and said, "I've been shot. I need you to call 911." He gave me this look, said, "No, that can't be it," and proceeded to talk to my friend out his driver's side window. I repeated myself a few more times and no one reacted; they just kept talking. I finally leaned forward and said it one more time. At this point, my

friend looked over, saw the blood, and realized I wasn't kidding. His training kicked in and he started asking me one-word-answer type questions, like "What's your name?" "What day is it?" He kept me from going into shock.

Next thing I remember, I heard the sirens. Police surrounded the truck with guns drawn yelling at us to get out of the car. Two officers approached the driver's side and threw the door open while yelling, "Get out of the car." My friend turned to them and said, "I'm a police officer, badge and gun are on the floor, and I'm not leaving her until the paramedics are here. Arrest me when it's over." The look of horror on all of their faces when they realized they knew us I will never forget.

I was taken to the hospital, rushed into surgery, and spent the next two weeks in ICU. It's all a huge blur to me.

The 40-caliber bullet went straight through my spine. I have never been able to walk again since that night.

The next two months were spent in a hospital and rehab facility, and I spent the next year trying to wrap my head around that night. I probably either cried or screamed from frustration every single day that year. If I would have curled up in a ball and stayed there, no one at that point would have blamed me.

That first year I went through the lowest point in my entire life. I spent it fighting with the doctors, insurance companies, getting physical therapy, all while trying to deal with all of the emotions and anger I was feeling. When I got to the point where I could get through a day with only needing one nap and not six, I started trying to figure out what it was I was going to do with my life. I knew I'd be limited not being able to stand or walk, but I knew I needed to find something.

If you think the hardest part of learning you are paralyzed would be the idea of never walking again, you would be wrong. The hardest part to

handle out of everything was how this was going to affect my son.

You see, when this happened, I was a single mother of a four-year-old boy. My son's biological father left and had nothing to do with him. For those of you who have children, family you would do anything for, you know what I'm talking about: You can do anything to me, but don't you dare hurt my child. I could see how this was affecting him, how he was hurting, how he was going without things a mother should be able to give her child. I couldn't teach him to ride his bike without training wheels, catch him when he jumped into the pool, or how to kick a soccer ball, and that was just eating me up inside.

Within a few months of my shooting, I took that anger I had and let it fuel this fire starting inside of me.

I HAVE to be a mother. Walking or not, I don't have a choice. I have to fight for my son. Every day I'd cry and scream from the depression, the frustration, the anger, and this little face would walk over to me. He'd rub my back. He'd kiss my cheek. He'd throw his arms around my neck and I'd hear his voice say, "It's ok, Mommy. I'll fix it." He deserves the

world. No one else but me is going to give it to him. I have to fight.

One year and nine months after I was shot, my deposition was taken. I rolled into the room, saw that court reporter, and it's like this light bulb went off. I already sit all day, my hands, brain, eyes, etc., they all still work. It hit me like a ton of bricks; this is what I can do. Funny thing was, a few years before I was paralyzed, I had made an attempt at court reporting school and quit six, eight months into it. It was too hard. I didn't have the time. I had every excuse in the book why it just wasn't going to work back then. Now, here I have ten more excuses and I think I can make it work now? Hell, yeah, I can.

I left that depo, went straight home and looked up that school I had gone to and made my appointment to meet with them. Almost two years to the day of when I was shot, I started theory a second time. I fought through the back pain, the nerve pain (neuropathy), the insomnia, other medical issues that would pop up, I had doctors' appointments, physical therapy four days a week, childcare issues, and money issues as I was dead broke. Trust me, it

I'm instantly swept back to childhood and one of my earliest memories: The family all gathered around the TV to watch. I was too young to really understand it, but I've always believed that those early years of watching this show helped shape my lifelong interest in the odd, the occult, the unexplained and the unexplainable, science fiction. And, gosh, do I still love Rod Serling's melodious voice!

I was absolutely glued to the TV all day, watching episode after marvelous episode, stunned by how the show — advanced for its time but primitive by today's standards — has withstood the test of time. Good grief, these shows originally aired from 1959 to 1964! I was two years old when it started; seven years old when it ended. 55 years later, I'm completely hooked — not by the nostalgia of it all, although that's certainly part of it — but because they're good.

I'm one of those people who generally gets bored "just" watching TV, and I usually divide my attention

between whatever's on TV and reading my e-book. Periodically, I flip out of my book to check my e-mail or see what's up on Facebook.

About the time my husband came back inside from whatever he was doing out there, (and he, too, became instantly hooked,) I did something I rarely do: I posted a Status on Facebook, that I was glued to the Twilight Zone marathon. Moments later, a good friend replied to my post, that they, too, had tripped over it and were also entranced (and SHE wasn't even born when the shows aired)! She commented that she had her laptop out so she could multitask on some work while they watched.

Even more amazing to me than how doggone GOOD these shows are — not "were" — ARE — was the fact that I remembered seeing some of the episodes! I could even visualize where everybody in my family was sitting in our old family room in Grayslake, Illinois. And when I swore up and down that we were watching a very, very young Cloris Leachman, and my husband disagreed, I flipped out of my e-book app yet again and looked up the episode and, sure enough, I was right. From then on, my husband and I were playing tag, seeing who we could recognize, or wondering who this actor or that one was. As fast as I could thumbtype, Google was providing me with the answers.

Somewhere along the way, it occurred to me how very amazing this is: I'm holding in my hand a small device that has more computing power than the best computers that the government probably had in the infancy of computing during that very era that these shows were first aired. I'm instantly communicating not only with my friend at the other end of the state, who's watching the same thing I'm watching, but with others who popped into the conversation with Likes or comments.

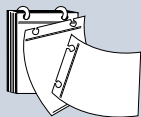
