What is Cystic Fibrosis?

Since 1955, the mission of the Cystic Fibrosis Foundation is to assure the development of the means to cure and control cystic fibrosis (CF) and to improve the quality of life for those with the disease. The CF Foundation tirelessly pursues its mission by supporting scientific research, which is dedicated to the discovery and development of new therapies. At the same time, it funds and accredits a network of specialized treatment centers that provide state-of-the-art care for people with CF.

In 2004, the CF Foundation received "top billing" by *SmartMoney* magazine, as the leader among U.S health/research charities for keeping our administration costs to a minimum, while maximizing funds for medical programs. Our efficiency remains strong – more than 90 cents of every dollar raised is available for investment in CF programs. It also continues to make our patients strong because when the CF Foundation began, few children lived to attend elementary school.

Who is the Cystic Fibrosis Foundation?

Cystic fibrosis (CF) is a genetic disease affecting over 30,000 children and young adults in the US today. A defective gene causes the body to produce an abnormally thick, sticky mucus that clogs the lungs and leads to life-threatening lung infections. These thick secretions also obstruct the pancreas, preventing digestive enzymes from reaching the intestines to help break down and absorb food. The mucus also can block the bile duct in the liver, eventually causing permanent liver damage in approximately six percent of people with CF.

With over 10 million Americans as unknowing and symptomless carriers of the defective CF gene, cystic fibrosis occurs in one of every 3,500 live births. With breakthroughs in pre-natal testing in recent years, 80% of patients are diagnosed by age three, and approximately 1,000 new cases are diagnosed each year.

When the defective CF gene was discovered in 1989, few children lived to experience pre-school. Today, the median age for survival is 36.8 years. Semi-annual hospital visits, daily breathing treatments, and hourly medications are simply a way of life for those living with cystic fibrosis. Patients struggle to gain weight, maintain a healthy diet, and avoid exposure to possible infections, all while balancing the struggle of everyday life. What many healthy adults remember as the innocent and simple days of childhood will never exist in the minds of these young people. For many, each morning includes breathing treatments, medications, and enzymes before even stepping on the playground.

What Is Marathon Golf: 100 Holes to a Cure?

Marathon Golf is for the avid golfer who is looking a different way to spend their day on the links. Traditional golf rules and regulations are tossed out the window as the goal of the day is to play at least 100 holes in one day. As the sun rises over the trees on the course, everyone begins with a shotgun start with one golfer per cart and two golfers per hole. The "score" is based on how much money a participant raises, whether by flat donations and/or a pledge-per-hole donation. There is a spirit of competition and a sense of urgency on the course— the more holes played, the more funds raised.

By making smart investments in research, partnering with sound pharmaceutical developers, and building relationships with local supporters, the CF Foundation continues "adding tomorrows every day." Without continued financial support, the Cystic Fibrosis Foundation cannot fund the research and the development pipeline slows dramatically.
