1. Each eligible participant may receive up to \$50.00 per year toward payment for completed classes or coursework. Each participant shall submit a co-payment of at least \$5.00 for each training segment.
2. Rebates are not granted without **BOTH: proof of purchase AND copies of training cards.** Sorry, no exceptions.
3. Under no circumstances shall the rebate amount exceed the actual cost of the training.
4. Health and safety training must have been completed after 07/01/2011 and meet the mandated requirements.
5. If you received a scholarship last year, you may apply again this year for up to \$50.00 for the cost of CPR and/or first aid RENEWAL. There is also a \$5.00 co-payment for each training segment.
6. The health & safety scholarships are funded by the California Department of Education-Child Development Division on an annual basis. There are NO GUARANTEES that you will be reimbursed. Reimbursements are contingent upon the availability of funds and are allocated on a first come, first served basis.
