### Lessee agrees to:

1. Lessee will defend all claims arising out of or relating to leased GOLF CAR s while on event property, from delivery to pick up inclusive, and shall indemnify and hold harmless lessor, NHSRA, Crunkleton Holdings, LLC. and its agents, employees and representatives against any and all claims, liabilities, losses or other causes of action, and agrees to procure and keep in effect during the term hereof public liability and property damage insurance protecting Lessor and Lessee for bodily injury and property damage. NHSRA EVENT INSURANCE
2. Return said GOLF CAR in as good as condition as received and agrees to pay for any damages sustained while GOLF CAR is in Lessee's possession.
3. In the situation whereas Lessee fails to operate GOLF CAR within the rules and requirements of the event facility owners and event organizers the Lessee risks forfeiting event use of GOLF CAR with no refund of any fees paid.
4. Pay for rental of said NB vehicle/GOLF CAR as quoted above, in advance. No refund of any kind.
5. Render Lessor harmless if mechanical failure to equipment prevents delivery or pick up.
6. NB Golf, LLC, NHSRA, Crunkleton Holdings, LLC. Assumes no responsibility or liability for any damage or injury to any person or persons and/or property.
7. Lessee agrees to operate GOLF CAR within the rules and requirements of NB Golf, LLC, Crunkleton Holdings, LLC, NHSRA and Facility owners. Failure to do so may risk forfeiting event participation eligibility and the use of the GOLF CAR with no event participation refund of fees reimbursed to Lessee.
8. By consummating this Agreement by your signature you authorize NB Golf, LLC to charge your method of payment for any damage or incidentals. I Lessee am responsible to have a full working knowledge of said rules and requirements before operation of GOLF CAR. Instruction Class to be done at pickup.
9. Renter or Lessee or Lessee's assignee of operation of the GOLF CAR assumes liability of damage to said GOLF CAR except normal wear and tear.

## TERMS AND CONDITIONS

- 1) I agree to pay in the event the GOLF CAR is lost, stolen or damaged the replacement or repair cost at retail value, not to exceed. (\$7,000.00 ) ( Initial )
- 2) **Other fees, in addition to the GOLF CAR rental rates:**
- A. A fee of \$250.00 will be charged if the GOLF CAR engine governor is tampered with or modified during the event rental in any way.
- B. The full GOLF CAR rental amount will be charged for cancellations within 10 days prior to the event or for GOLF CAR s not picked up at the event.

- C. A 15% surcharge will be added to the above rental rates for orders placed within 5 days of the Wednesday before the event weekend. Late orders cannot be guaranteed and will be filled on an "as available" basis.
- D. A fee of \$15.00 per key will be charge for lost GOLF CAR keys.
- E. A fee of \$75.00 will be charged for locks and/or chains that are required to be cut off the GOLF CAR
- F. A fee of \$75.00 will be charged for PRIVATE decals/stickers or paraphernalia applied to GOLF CAR s and not removed before returning GOLF CAR.
- G. LATE RETURN POLICY - A fee of \$100.00 will be charged if the rented GOLF CAR is **not returned** to the GOLF CAR rental compound by 6:00 AM to 9:00 AM on the day following the last event of the NHSFR week.

### 3) For safety and security:

- A. All vehicles shall be monitored at all times to prevent theft or vandalism when parked.
- B. When practical, it is a good idea to assign a person to a specific vehicle. It will discourage abuse of the equipment.
- C. Do not modify any of the factory settings on the engine. Modifications can result in damage to the vehicle as well as incurring additional fees.
- D. All vehicle settings are checked for correct working order before delivery.
- E. Only the amount of persons the unit can seat in installed NB Golf, LLC seats are allowed on the vehicles at any one time.
- F. Do not overload any GOLF CAR vehicles.
- 4) Additional Payments - The credit card information provided on the Credit Card Authorization Form will be utilized to process payment of any additional rental or fees due as stated above. ( Initial )

## SINGLE EVENT GOLF CAR CREDENTIAL POWERED GOLF CAR POLICY AND RELEASE OF LIABILITY

1. ALL powered GOLF CAR s in use on the property of any facility must be registered. Registration will be proven through a Single Event Credential Sticker which must be affixed to the approved GOLF CAR on the front driver's side in the lower corner of the windshield or lower corner front hood. Cost \$25.00 Facility Fee.
2. Proof of general liability insurance (or automobile liability for the event the GOLF CAR being registered for) with a minimum amount per occurrence.
3. The use of powered GOLF CAR at facility will be restricted to business event use only.
4. GOLF CAR s will be driven in a safe, slow, and respectful manner and shall at no time exceed any posted or designated speed limit at the event property. At all times drivers will yield to pedestrians. Anyone observed driving in a careless or unsafe manner, including and without limitation, in violation of any provision of this GOLF CAR policy and release of liability, will have their Single Event Credential revoked. The undersigned agrees to be responsible for compliance with all laws & government regulations in the use of the vehicle.
5. GOLF CAR s must be driven by a licensed driver at least eighteen (18), unless applicable state law requires a higher age limit. The number of passengers may not exceed the manufacturers designed and installed seating capacity and/or the capacity indicated on the Credential. All passengers must be seated during operation.
6. Alcoholic beverages are not permitted in any GOLF CAR s. No alcohol is to be consumed by any driver or passenger while the GOLF CAR is in use, no driver shall operate any GOLF CAR while under the influence of a controlled substance.
7. Only GOLF CAR equipped with factory installed (or equivalent light source) front headlights may be operated after daylight hours.
8. GOLF CAR usage will not be allowed in restricted areas or during times not authorized by facility management. No GOLF CAR shall be operated on public roads.
9. The (Lessee) undersigned hereby agrees to release, hold harmless, indemnify and defend NB Golf, LLC, Crunkleton Holdings, LLC, NHSRA, their respective subsidiaries and affiliates, and their respective members, shareholders, officers, directors, agents, employees, related or affiliated companies, sponsors, trustees, receivers, successors, subcontractors and assigns, the damages including reasonable attorney fees arising from injuries to person(s) or damage to property which may arise from the use of these vehicles by the **Lessee**/company named below, its employees, agents, or representatives. The obligations herein shall extend to claims alleging the sole negligence, willful misconduct or violation of law of an Additional Insured Party until adjudicated as such by a court of common law. I agree that NB Golf, LLC, Crunkleton Holdings, LLC, NHSRA, its subsidiaries and affiliates, and their respective members, shareholders, officers, directors, agents, employees, related or affiliated companies, sponsors, trustees, receivers, successors, subcontractors and assigns, the City Recreational Facilities do not accept any responsibility or liability by virtue of registering powered GOLF CARs .

**I have read, understand and accept all the terms of use for a NB GOLF, LLC GOLF CAR on facility properties. Failure to comply with these terms may result in revocation of the Single Event Credential, the GOLF CAR being impounded and/or forfeiture of event GOLF CAR privileges.
