The Association of Engineering Professionals in Society (AES) is organising a Seminar on “Products & Management System Certification - Construction Products, Information Security, Occupational Safety and Health, Food Safety and Jewellery”, which will be held on Friday, 30 September 2011 at Chiang Cheng Studio Theatre, The Hong Kong Polytechnic University.

The seminar is one of the activities held under the project entitled “Enhancing the standard and professional knowledge of testing and certification in Hong Kong and promoting the industry comparative advantages for co-operation opportunities with enterprises in the Mainland”, funded by the Professional Services Development Assistance Scheme (PSDAS) of the HKSAR Government.

In the past years, Hong Kong’s testing and certification industry has been providing a high volume of testing and inspection services for goods manufactured and services provided locally and externally. To meet the growing concern of safety and quality requirements, a number of product and management system certification has been established for different trades which have varied characteristics, and nature of their current and potential needs for testing and certification services.

The seminar aims to familiarize the industries with the management system certification for products and services including construction products, information security, occupational safety and health, food safety and jewellery. Speakers from related laboratories, institutes, and organisations will brief the practitioners of the industry and stakeholders on the procedures and requirements for their products or systems to be certified and will share their experience in providing the testing and certification services in Hong Kong and the Mainland.
