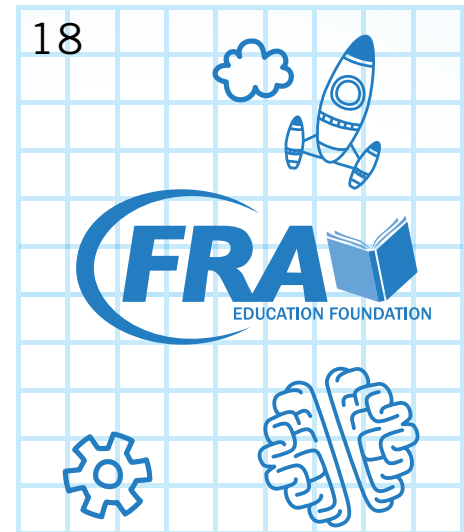

## Supporting Education

**SEPTEMBER, AS WE ALL** know, starts the new academic year for schools across our nation. Elementary, middle, and high schools, colleges and universities will be booming and students of all ages will start that age-old “back to school” routine. The classic images of bus stops, crossing guards and stacks of books still resonate, but each new generation of students perceives those images a bit differently. Chalk boards have been replaced with white boards and online homework postings; smart phones are performing the functions formerly handled by calculators and many students are submitting their homework and test answers via computer. Non-traditional forms of education in diversified fields of study are becoming the norm and advanced studies are being offered via computer from the comforts of our homes.

Not since President Franklin D. Roosevelt has the need been so pressing for increased learning to transform the economic and social structure of the United States. Education paves the way to a higher boom of learning and contribution to our nation, regardless of the years of conflict in which our nation has been involved. The Servicemen's Readjustment Act of 1944 (P.L. 78-346), commonly known as the G.I. Bill, provided payments of tuition and living expenses for WWII veterans to attend university, high school or vocational school, as well as low-cost mortgages and low-interest loans to start a business. Since then, education benefits available to service members and veterans have been updated to include the Veterans Education Assistance Program (VEAP), the Montgomery GI Bill (MGIB), Tuition Assistance (TA), the Post-9/11 GI Bill, and now Congress

is considering legislation (H.R. 357 and S.257) to provide in-state tuition at state universities and colleges for military students, regardless of the servicemember's resident status in that state. Opportunities are also available to allow our active, Reserve and retired service men and women to transfer some of those benefits along to family members and there are avenues that allow service members to earn valuable education credits for the skills they've acquired during their military service.

As you'll read in this month's feature article on the FRA Education Foundation (which begins on page 18), promoting education is a long-standing tradition for FRA. I recently had the privilege to serve on a congressional panel supporting online education and other forms of distance and electronic learning. To paraphrase a quote from this panel, “Education should not be hindered because of administrative processing, but [should be advanced by] a transparency of acceptance by accredited institutions.” Our recent partnership with

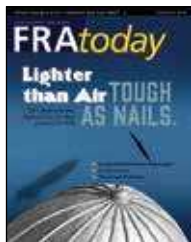

## Agent Orange Concerns

I'm concerned about the lack of action on the “blue water” sailors issue as related to Agent Orange exposure in Vietnam. It has been YEARS kicking around Congress. Are you and the do-nothing Congress waiting for the rest of us to die so you won't have to worry about it any longer? My brother has already died and I have been treated for prostate cancer. I realize that the VA probably doesn't want several thousand more Agent Orange-related cases to deal with, but that is too bad. The government doesn't mind sending the military into harm's way, but it sure likes to look the other way when problems like Agent Orange exposure show up years later.

**FRA Response:** We're glad to report that we are making progress on the Agent Orange/Blue Water Navy issue. Both the House and Senate versions of the 2015 Defense Authorization bills (H.R. 4435/S. 2410) include an identical provision that directs the Joint Services Record Center (JSRC) to do a comprehensive search to determine which ship's crews are eligible under current law for presumption coverage for exposure to Agent Orange. Currently the veteran filing a disability claim must provide proof that his ship entered a harbor or inland waterway. If enacted, JSRC will create a definitive list of ships and eligibility dates. This will allow many veterans to be able to receive benefits that have been denied in the past. FRA is also working to expand presumption for crew who served off the coast of Vietnam.

## TRICARE Prime Access

After reading about the return of TRICARE Prime to some service areas, we thought it would be great to get our son (a full-time college student) back into the program. After spending about 45 minutes on the phone with TRICARE South, I was advised that my son is within the 100-mile [from a military treatment facility] requirement for coverage, but our doctors don't meet the 40-mile requirement. So, it seems that only half the problem has been fixed. Rather than have our son travel 35 miles to a doctor [who meets the distance requirement], we will leave him on TRICARE Standard coverage. This allows him to travel only five miles to see [the doctor who's been treating him].

**FRA Response:** The law grants authority to the Secretary of Defense to “determine whether to maintain a TRICARE network of providers in an area that is between 40 and 100 miles of a military medical treatment facility.” DoD restricted reenrollment to those who live within 100 miles of a current or former military treatment facility, but beneficiaries must see a primary care provider who practices within 40 miles of an existing base.

## Senate Action on NDAA is Delayed

**WHEN CONGRESS ADJOURNED FOR** its summer recess, only the House had passed its version of the FY 2015 National Defense Authorization Act (NDAA-H.R. 4435). When senators return on September 8, 2014, they will only have 10 days of session before the start of the new fiscal year (October 1, 2014). There already are over 140 floor amendments filed for consideration, and many more will be filed when the Senate returns. Several anticipated amendments impacting FRA membership include reducing the proposed pharmacy co-pay increase for retirees, concurrent receipt improvements, increasing active duty pay by 1.8 percent (instead of the one percent increase requested by the White House and in the current bill), elimination of the Survivor Benefit Plan/Dependency

Indemnity Compensation (SBP/DIC) offset, and early retirement credit for frequently mobilized reservists. After the Senate passes its bill, the House and Senate will appoint a conference committee to resolve the differences between the two measures. The conferees will write a bill that can pass both chambers and be signed into law by the President.

Members are strongly urged to use the FRA Action Center to ask their senators to support floor amendments that will repeal provisions in the current bill to dramatically increase pharmacy co-pays for retirees, reduce the FY 2015 active duty pay increase, and increase out-of-pocket housing costs for active duty personnel. #### Honor Flight Bill Passes House

The House of Representatives recently passed the "Honor Flight Act" (H.R. 4812), a bill sponsored by Rep. Cedric Richmond (La.). The bill would codify the process by which the Transportation Security Administration (TSA) provides expedited and dignified passenger screening services for veterans traveling to visit war memorials built and dedicated to honor their service in Washington, D.C. Expedited screening services will save veterans time and show them their proper respect and appreciation.

"The measure seeks to pay a debt of gratitude to a group of Americans who were willing to make the ultimate sacrifice to ensure that we are able to enjoy the freedoms that we have today," said Rep. Richmond. "Although we may never be able to fully repay our veterans for their bravery, our national memorials bring into focus their lasting contribution and their impact on American history. It just makes sense that they are treated with the reverence and gratitude they deserve when visiting memorials erected in their honor."

#### Retirement and Pay Commission Releases Interim Report

The Military Compensation and Retirement Modernization Commission (MCRMC) recently released an interim report. While the 358-page interim report does not make any recommendations for changes to benefits, it does document the commission's understanding of the overall current military compensation and benefit programs; relevant laws, regulations, and policies; associated appropriated federal funding; and historical background for the uniformed services' compensation and benefit programs.

The MCRMC stated that while compensation funding has increased substantially over the last two decades, the increase is mostly due to inflation (particularly medical inflation) and 13 years of war. The MCRMC also found that while compensation funding has increased, it has remained consistently around 30 percent of the DoD budget. The MCRMC did note that Reserve compensation deserves special attention for reform since the status has changed from a strategic reserve to an operational reserve that is mobilized and deployed frequently.

The 2013 National Defense Authorization Act (NDAA) established a nine-member commission to review military compensation and retirement programs and make recommendations for their modernization to the President and Congress in February 2015.

FRA has consistently expressed serious concerns about cost-driven efforts to "reform" pay and benefits, and contends that the current pay and benefit package is key to recruiting, retaining and sustaining military readiness. The Association provided a written statement to the Commission expressing FRA concerns; that statement, dated December 20, 2013, is available on the FRA website. FRA DLP John Davis has met with MCRMC Commissioners and staff to provide an enlisted perspective on pay and benefit changes. FRA will continue to closely monitor the activities and deliberations of the Commission. **Bipartisan VA Reform Agreement**

FRA NED Thomas Snee attended a bill-signing ceremony on August 7 to watch as President Obama signed into law House- and Senate-passed legislation (Conference Committee report for H.R. 3230) to reform the Department of Veterans Affairs (VA). The legislation includes:

- Requiring the VA to offer non-VA care to any veteran enrolled in the VA health care system as of September 1, 2014, or who is a newly discharged combat veteran, if such veteran is unable to secure an appointment within 30 days or resides more than 40 miles from the nearest VA medical facility;
- Extending the pilot program to provide rehabilitation services to veterans with complex-mild traumatic brain injury (TBI);
- Improving care for veterans experiencing military sexual trauma;
- Allowing the VA Secretary to expedite the firing of senior VA managers who are accused of mismanagement;
- Hiring more physicians, other medical staff, and improving VA infrastructure;
- Providing in-state tuition to veterans and eligible dependents using the Post 9/11 GI Bill;
- Providing Post 9/11 GI Bill benefits to spouses of service members who died in the line of duty;
- Establishing a Congressional Commission on Care to evaluate access to care throughout the VA health care system; and
- Authorizing 27 major facility leases in 18 states and Puerto Rico.

The final bill will cost nearly \$17 billion over 10 years with \$5 billion in offsets, making it less expensive than previous VA reform legislation passed by the House and Senate. The Association believes that taking care of veterans is a part of the cost of defending the nation. FRA stresses that no veteran who is eligible for health care services from the VA should be forced to wait too long or travel too far to get medical treatment and services earned through his or her service. FRA welcomes bipartisan cooperation in finding a solution but is concerned how this reform might impact military treatment facilities (MTF). **Senate Confirms New VA Secretary**

The Senate voted unanimously (97-0) to confirm Robert McDonald, President Obama's nominee to serve as Secretary of the Department of Veterans Affairs (VA). He was nominated by the President on June 30, 2014, and unanimously approved by the Senate Veterans' Affairs Committee (SVAC) the following week. The new VA Secretary pledged to transform the struggling agency, saying that "systematic failures" must be addressed. McDonald graduated West Point in 1975 and served as a paratrooper in the Army's 82nd Airborne Division. In 1980, McDonald left the Army as a captain for a 33-year career at Procter & Gamble, including serving as CEO from 2009 to 2011.

McDonald, age 61, said that taking care of veterans is personal for him. His father served in the Army Air Corps after World War II, and his wife's father was shot down over Europe and survived harsh treatment as a prisoner of war. Another relative was exposed to Agent Orange in Vietnam and receives care from the VA. McDonald also has a nephew who is in the Air Force, and deployed in the Middle East. McDonald replaces Acting VA Secretary Sloan Gibson, who headed the agency starting in early June. Eric Shinseki, Obama's first VA secretary, resigned on May 30, 2014, when a scandal erupted over wait times for veterans to see a doctor.

**VA Opens Burn Pit Registry**

The Department of Veterans Affairs (VA) has initiated a new burn pit registry to report exposures to airborne hazards such as smoke from burn pits, oil-well fires, and other pollutants or exposures encountered during Desert Shield/Storm and Post-9/11 deployments. The registry is required to accurately document whether such exposure harmed or caused other illnesses or diseases. VA officials acknowledge that troops may suffer from illnesses related to environmental exposures, and has established a surveillance program for service members exposed to the known carcinogen hexavalent chromium from a water treatment facility near Basra in 2003. However, the VA also said there is not yet enough scientific evidence to prove that exposure to burn pits causes long-term health problems. **Congressional Caucus for Veteran Caregivers**

House Minority Leader Nancy Pelosi (Calif.), Senator John McCain (Ariz.), Senator Jack Reed (R.I.), and Chairman of the House Veterans' Affairs Committee (HVAC) Jeff Miller (Fla.) started a new bipartisan "Hidden Heroes Congressional Caucus" to address the challenges facing the 5.5 million volunteer caregivers to America's wounded warriors.

These family members and loved ones shoulder the responsibility of bathing, feeding, dressing, managing medication and injections, arranging for rehabilitation, all while most are raising a family. A recent RAND study commissioned by the Elizabeth Dole Foundation estimates the services they provide save our nation \$13.6 billion annually, yet these caregivers too often pay a price, suffering physical and emotional stress and illnesses; difficulty maintaining employment; financial, legal and family strains; and isolation.

**VA and TRICARE Dental Information**

The VA has recently implemented a national dental insurance program for individuals enrolled in VA health care and in the CHAMPVA program. Premium rates will vary depending on your geographic region and the plan option you select. Three options are available: basic, enhanced and comprehensive. These plans range from about \$8 for basic up to about \$27 for comprehensive.

Veterans will not be getting dental care performed by the VA, but veterans must be signed up with the VA for health care to be eligible for the dental insurance plan. This is the first time that the VA has assisted veterans with dental care except for those veterans who are rated at 100 percent service-connected disability, have a service-connected disability for a dental injury, or are on the VA Vocational Rehab program.

The Defense Health Agency (DHA) also recently released an eight-page newsletter for TRICARE Dental Program (TDP) enrollees. **IG Claims One-Third of Finalized Claims Inaccurate**

The House Veterans Affairs Committee (HVAC) held a hearing to review the VA's progress in achieving the goal of ending its disability compensation claims backlog by 2015 and exploring claims of whistleblower retaliation and "cooking the books" within VBA. At the hearing, Allison Hickey, VA Under Secretary for Benefits, insisted that the claims backlog has been significantly reduced. The VA has set a goal of processing all disability claims within 125 days with 98 percent accuracy and says the disability claims backlog has been reduced by 55 percent, from more than 600,000 pending claims pending beyond 125 days early last year to 275,000 claims today. HVAC Chairman Jeff Miller (Fla.) and Assistant Inspector General for the VA Linda Halliday said they don't believe the VA's reported statistics.

Hickey indicated that VA completed a record 1.2 million disability rating claims in 2013, and that the agency is on track to complete more than 1.3 million rating claims this year and pay a total of \$67 billion in benefits. Hickey also said that more than 90 percent of the claims are being processed electronically. The IG office also reports that over a two-month period, nearly one-third of the adjudicated claims were inaccurate.

**House Panel Probes VA Cover-Up while VA Requests Monthly Meetings with Local VSOs**

The House Veterans' Affairs Committee (HVAC) held a hearing regarding the cover-up of excessive wait times at veterans' hospitals. The hearing focused its attention on federal employees who stepped forward to expose fraud, sometimes jeopardizing their careers to do so. The committee also heard testimony from the Office of Special Counsel (OSC), who provided appalling examples of patient neglect after hospitalization—indicating that substandard care is more than a waiting-list problem. As reported in the August 2014 issue of *FRA Today*, senior management at the VA has been accused of retaliating against whistleblowers and is being investigated by OSC.

In related news, Acting Secretary of Veterans Affairs Sloan Gibson recently met with representatives from FRA and 25 other Military and Veterans Service Organizations (MSOs and VSOs) to confirm his commitment to addressing systemic problems in accessing VA health care. During the meeting, he updated the representatives on the VA's work with the Office of Special Counsel (OSC) to restore veterans' trust in the system and on VA's progress in reaching out to get veterans into clinics and off waiting lists. He told MSO and VSO representatives that he looks forward to working with them to better serve veterans. He also has directed all VA Medical Center leadership to hold monthly meetings with VSOs and community partners.

**New VA Secretary Announces Town Hall Events Across the Nation**

Secretary of Veterans Affairs Robert A. McDonald has directed all Veterans Affairs (VA) health-care and benefits facilities to hold town hall events by the end of September to improve communication with, and hear directly from, veterans nationwide.

"Caring for veterans is a calling, and our first commitment is to provide veterans and their families the timely, quality care and benefits they have earned and deserve through their service to our nation," said Secretary McDonald. "As we seek continual improvement and to rebuild trust among veterans, it is critical that we continue to listen to and learn directly from those who use our system."

Secretary McDonald has informed the Under Secretaries of Health and Benefits that each VA medical center and regional office should hold at least one town hall meeting with veterans by the end of September. Meetings are designed to allow feedback from veterans, family members and other beneficiaries. Each facility will also welcome input from congressional stakeholders, veteran service organizations, non-governmental organizations, and other community partners. Details of events in each location will be forthcoming from local facilities.

**TRICARE Increases Access to Qualified Mental Health Counselors**

The Defense Health Agency (DHA) recently announced that TRICARE beneficiaries can now choose between two qualified mental health counselor types: independently practicing TRICARE Certified Mental Health Counselors (TCMHC) and Supervised Mental Health Counselors (SMHC).

TRICARE will authorize TCMHCs as independent providers who meet specific qualification criteria. They must have a master's degree from a mental health counseling program accredited by the Council for Accreditation of Counseling and Related Education Programs (CACREP) and pass the National Clinical Mental Health Counseling Examination (NCMHCE) by Jan. 1, 2017. TCMHCs can independently treat TRICARE beneficiaries as well as oversee SMHCs. SMHCs will continue to practice under the referral and supervision of TRICARE-authorized physicians while getting the required 3,000 hours of post-master's clinical practice to become a TCMHC.

Some beneficiaries may worry they won't be able to continue seeing their current mental health care provider under this new guidance. "This does not have to be a concern," says Patricia G. Moseley, Ph.D., military child and family behavioral health senior policy analyst at the Defense Health Agency. "Providers have an extended time period to gain the necessary credentials to become authorized for independent practice under TRICARE, if they aren't already. This rule gives providers more time to meet the requirements and allows beneficiaries to keep their current supervised mental health counselors."

The Defense Health Agency is tasked with making military medicine stronger, better and more relevant for the future. This change moves us one step closer to the goal of ensuring the availability of well-qualified, independent providers for our beneficiaries. **SecDef Orders Military Health Care Review**

Secretary of Defense (SecDef) Chuck Hagel recently ordered a comprehensive review of the Department of Defense (DoD) health care system. The 90-day review will be led by Deputy Secretary of Defense Bob Work, with the assistance of the acting under secretary of defense for personnel and readiness and the assistant secretary of defense for health affairs, and the direct participation of the secretaries of the military departments and the service chiefs. In addition, Secretary Hagel has asked Deputy Secretary Work to solicit the perspectives of outside experts in the areas of patient safety and quality care. The review will focus on the following core areas: access to health care, safety of care, and quality of care. The final report was to be delivered to him no later than September 29, 2014.

**FRA Discusses Awards and Decorations with DoD**

FRA's Assistant Director of Legislative Programs Stephen Tassin participated in a conference call headed by the Office of the Secretary of Defense (OSD) to discuss combat and valor awards. The goal was to determine if the program adequately recognizes all levels of combat valor, and if award processes and authorities are properly aligned with the joint nature of warfare. Among the items discussed were the question of whether service members with PTSD and TBI should be awarded the Purple Heart, and how to best recognize service members who use remote technology to directly impact combat operations.

All associations that participated agreed that the services need guidance to ensure they are on the same page when granting awards to service members. Awards with a "V" device should have higher placement than those without a "V" device. The decision was made that the Purple Heart should not be awarded to service members with Post Traumatic Stress Depression (PTSD) since it is a disorder, not an injury. It should, however, be awarded to those with traumatic brain injury (TBI). Service members who use remote technology to directly impact combat operations should not be given special awards for their duty, but should be recognized using the current award system.

## Youth Activities

**YOUTH ACTIVITIES ARE** an important segment of our Association's work and can be a key element in our recruiting efforts, especially for the next generation. School is back in session, making it a great time to contact teachers and administrators about assisting with established programs like NJROTC, Sea Cadets, scouting and any other youth activity that will promote the FRA. It is also a great time to distribute posters and encourage area students to participate in FRA's Americanism Essay Contest and the FRA Education Foundation's scholarship program. Many of our branches have been involved in various youth-oriented activities for a long time and know the value of mentoring young people. Let's take a look at some of the programs.

Shipmate Tom Vatter, of Branch 93 (Patuxent River, Md.), reports a great love for youth activities. Branch 93 has been supporting youth programs since the branch was established in 1947, including Cub Scout Pack 413 (since 1947) and Boy Scout Troop 413 (since 1950). It is a tremendous honor to assist these young future leaders of America. Branch 93 also sponsors a Little League Baseball team by paying for uniforms, equipment and registration, as well as a youth football team in the community. Additionally, the branch sponsors an Amateur Athletic Union (AAU) girls' basketball team, which has done well in both state and regional championships. And lest you think the branch only supports extra-curricular events, Branch 93 shipmates award \$1,500 in scholarship funds to deserving high school students headed to college.

When asked how these youth activities are funded, Shipmate Vatter explained, "We do a *lot* of fund raising." Branch 93 sponsors a variety of

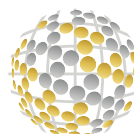

## How did Your Legislators Vote on COLA Cut?

FRA weighs in on a number of legislative initiatives that affect military pay and benefits, including the 113th Congress' efforts to cut annual cost-of-living adjustments (COLAs) for military retirees under the age of 62. Thanks to the outstanding grassroots support of FRA shipmates, the cut was repealed, but we thought readers might be interested in learning how their individual senators and representatives voted on instituting the cuts and then later repealing them.

The initial provision (Section 403) to cut the annual COLA by one percent for military retirees under age 62 (effective December 1, 2015) was part of the Bipartisan Budget Act (H.J.Res. 59), which set overall discretionary spending limits for fiscal years 2014 and 2015. The bill passed the House (332-94) on Dec. 12, 2013, passed the Senate (64-36) on Dec. 18 and was signed into law on December 26, 2013.

The COLA cuts elicited strong opposition from FRA and other veterans' organizations, which pressured members of Congress to repeal the measure. In February of 2014, the law was successfully repealed (S. 25) for service members who joined the military before January 1, 2014.

# EDUCATION FOUNDATION

September conjures up a wide variety of back-to-school images ... school buses, new shoes and backpacks, the start of football season and retail advertisements featuring stacks and stacks of school supplies. Whether you are a student yourself, have children or grandchildren who are heading off to school this fall, or just have vivid memories of your own school days, there's a high probability that September triggers some unique visions of "school."

With the start of the traditional academic year, it seems only appropriate that September also mark the beginning of the Fleet Reserve Association (FRA) Education Foundation scholarship year. As part of FRA's long-standing tradition, this issue of *FRA Today* honors the Foundation's scholarship recipients for 2014 and announces the release of applications for the 2015 awards. Since its establishment in 2009, the Foundation seeks various ways to partner with military and education professionals to promote lifelong learning opportunities and help scholars reach their educational, professional and personal goals.

This year's launch also coincides with the beginning of the Combined Federal Campaign (CFC), and we're happy to announce that the FRA Education Foundation is again participating. The CFC is the only authorized solicitation of federal employees on behalf of approved 501(c)3 charitable organizations. As an approved CFC charity (Code #80236), the Foundation makes its information available to all military personnel and civilian federal employees, which will expand awareness of our program, hopefully increase support for our scholarship fund and generate more applications for Foundation awards.

## **Rooted in the Navy Scholarship Program**

The FRA Education Foundation is an outgrowth of the FRA Scholarship Program, which began decades ago. The program's origin remains a little fuzzy, but all agree that FRA's involvement in supporting scholars started with our participation in the Navy's scholarship program.

"Back in the early 1980s, the Bureau of Naval Personnel (BUPERS) offered a booklet that listed 20 or 30 scholarships offered by various organizations, including FRA," recalls Past National President (PNP) George Kaye, who served as the Association's National Financial Secretary (NFS) from 1981 to 1997. "Those interested in applying for the various scholarships would request the forms from BUPERS, fill them out and return them to BUPERS. FRA and the organizations also advertised their scholarship offerings and listed the BUPERS address as the contact. BUPERS established a deadline and sent all the submitted applications to the respective organizations, who would then select their own recipients."

The exact date is unknown, but at some point, the Navy terminated its program and FRA picked up the banner and continued to offer scholarships to its members for their families.

"We offered two scholarships at that time," says Kaye, "the Fleet Reserve Association Scholarship and the Schuyler Pyle Scholarship [named for FRA's National Financial Secretary — 1945 to 1962]. The amount of the scholarships at that time was small, but during my tenure as NFS, we received donations for specific scholarships. The first was the Stanley A. Doran Scholarship and then others followed. Each donation spelled out specific criteria for the award. The Robert W. Nolan [former National Executive Secretary], Joseph R. Baranski [former National Treasurer] and Glenn F. Glezen [former NFS] Scholarships were established in honor

of these FRA leaders as a 'thank you for your service' and are funded by FRA's budget."

The program continued to grow, offering more and larger scholarships to deserving students. In 2000, FRA awarded \$37,141 to 16 students. By 2008, annual awards had increased to \$104,000 and the program benefitted 28 students.

"The FRA Education Foundation was established in 2009 in an effort to further expand awareness of, and participation in, FRA's scholarship program," explains Joe Barnes, president of the Foundation and FRA's former National Executive Director (NED). "Providing awards to deserving applicants is consistent with our mission and founding principles. As a 501(c)3, we are able to apply to participate in the Combined Federal Campaign (CFC). To make that possible, a foundation had to be established and a resolution (NBR 41-08) was approved by the Board of Directors and ratified by delegates to our 2009 national convention."

FRA oversees the Foundation, which is a totally separate entity. It has its own governing documents, a separate board of directors, a distinctive IRS designation and its finances are maintained in separate accounts. FRA is classified as a 501(c)19 organization and cannot participate in the CFC. As a 501(c)3 organization, the Foundation can accept contributions, which are considered charitable contributions for tax purposes.

"FRA Standing Rule 14 addresses the establishment of the Foundation and the relationship of the Foundation with the FRA Board of Directors and the overall organization. It also references leadership and IRS reporting requirements and other issues," elaborates Barnes. "There is currently a five-member Foundation Board, on which I have the privilege to serve as president. FRA's Finance Officer Steve Cox is the treasurer, PNP Larry Boudreaux is secretary, and PNP Gary Blackburn and PNP George Hyland serve as board members. Advisors are NED Tom Snee, Shipmates Harry Kantrovich and Jim Mathieu and Honorary Shipmate Jim Webb.

"Participation in the CFC is a big deal," Barnes continues. "The Foundation must apply annually and each application is reviewed to ensure compliance with CFC requirements. In addition to the expanded visibility and support it offers the Foundation and our scholarship program, it's also a recognition that we've met or exceeded the CFC's stringent standards for participation. We're very proud of that."



"The work of former NHQ staff members Finance Officer Paul Rigby, Shipmate Vince Cuthie and Admin Director Alicia Landis is noteworthy and significant to the growth and success of the scholarship program and the establishment of the Foundation," adds Barnes.

## Eligibility and Applications

FRA's scholarship program has traditionally been limited to FRA members, their spouses, children and grandchildren who are pursuing college degrees. The establishment of the Foundation has also expanded the scope of our audience to include non-members who are affiliated with the Navy, Marine Corps or Coast Guard through their own service or that of a spouse, parent or grandparent. This change is associated with CFC participation, allows a broader range of external supporters and also has a recruiting and retention benefit. Although anyone who has a connection to the Sea Services can apply for FRA Foundation scholarships, FRA shipmates and their family members qualify for a broader range of scholarships, several of which are funded through member legacy donations.

Some awards, particularly those funded through private donations and established trusts, have very specific eligibility criteria. Some require FRA membership; some are designated for graduate students, while others are limited to students pursuing undergraduate degrees. The Colonel Hazel Elizabeth Benn, USMC, Scholarship Fund has the most specific criteria, providing \$2,000 scholarships for unmarried, dependent children of persons who served or are now serving in the United States Navy as enlisted medical personnel assigned to and serving with the U.S. Marine Corps. (Applicants need not be affiliated with FRA to be considered.)

The Benn Scholarship was established by Colonel Benn's estate to honor the memory of one of the first active-duty female Marines selected for the permanent rank of colonel. Benn became Head of the Educational Services Branch of the Marine Corps and worked tirelessly to increase the potential for Marine Corps personnel to pursue college degrees.

Application forms for all FRA scholarships, as well as those offered by the Auxiliary of the FRA, are available at [www.fra.org/foundation](http://www.fra.org/foundation). The application deadline is April 15th of each year and applications must include a variety of additional documentation, such as transcripts, recommendations and an essay. Incomplete applications are the primary cause for disqualification, so applicants

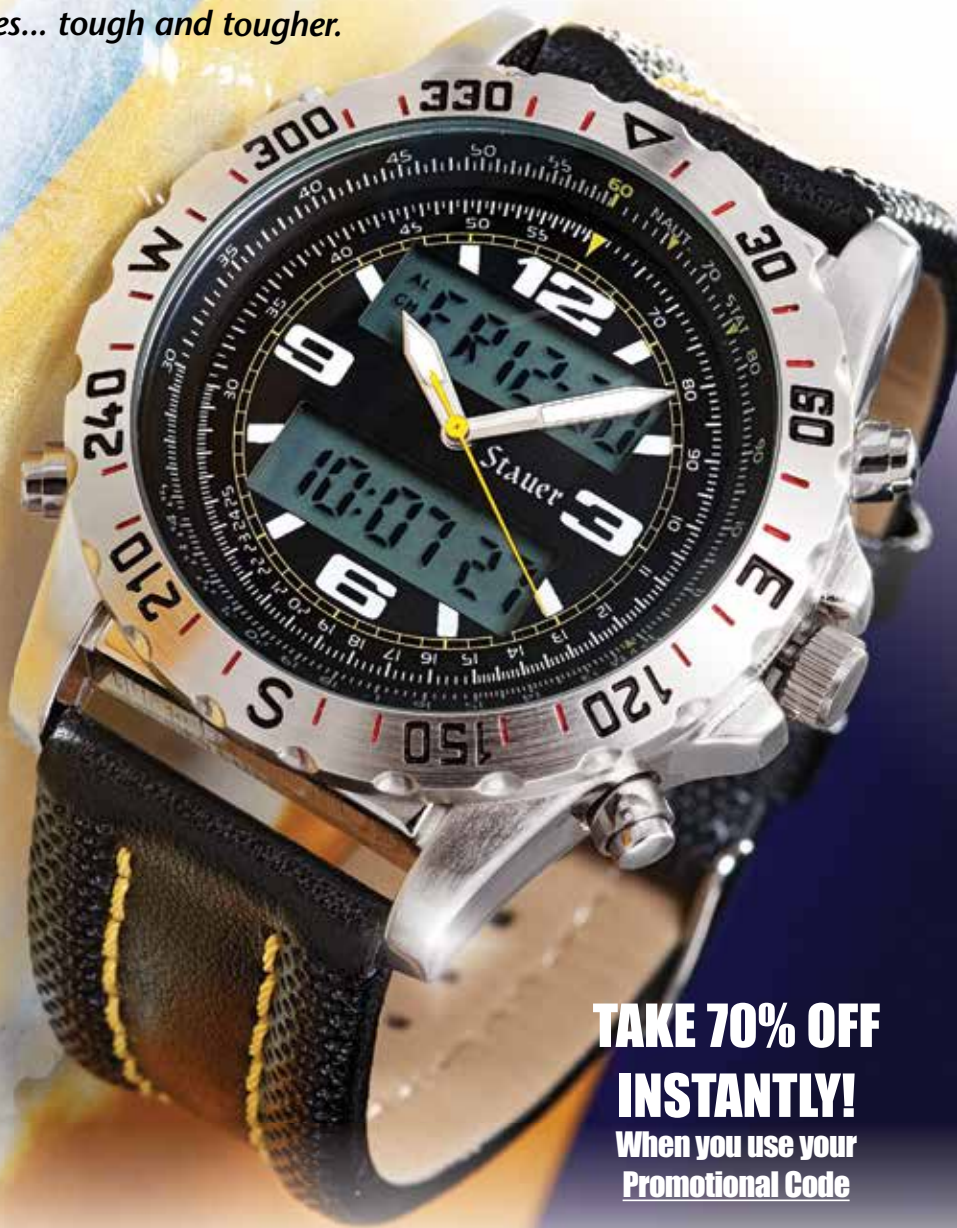

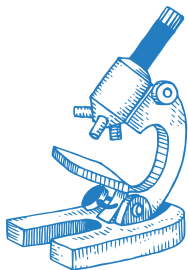

are encouraged to pay particular attention to all facets of the application package.

Marilyn Smith, the Foundation's scholarship coordinator, suggests

applicants ensure their application is clear, neat, and legible, as it makes a first impression on members of the selection committee, currently comprised of Shipmates Harry Kantrovich and Peggy Bair, and Communications Director Lauren Armstrong. "My second bit of advice is to put some extra time into the essay. It's the one chance applicants get to 'sell' themselves," says Smith. "The essay is the place for applicants to inform the adjudicators about their plans for the future, hardships they may have faced, accomplishments they've attained, and especially their hopes and dreams. Lastly, I strongly advise applicants to seriously consider whom they ask to supply them with a recommendation. It is through these recommenders that the adjudicators gain insight into the applicant and what makes him/her worthy to receive a scholarship."

## Selection Process

Selecting scholarship recipients is a very objective, two-step process, according to Smith. "The first review of eligible applications is carried out by a volunteer adjudicating committee, comprised of FRA shipmates and FRA staff members. In the first round, adjudicators classify applications as either 'Yes, this applicant is worthy for further consideration' or 'No, this applicant is not worthy to move forward.' Those applications that are selected for further consideration move to a second round, where they are again reviewed by the committee. In this step, each adjudicator ranks the applicants in numerical order, with their top pick being ranked first and so on. The adjudicators' rankings are then compiled and those applications with the highest composite ranking are offered scholarships."

Recipients are notified by mail in late June or early July and checks are distributed directly to the recipients' schools for use in the Fall semester.

## Awards

This year's awardees (listed on page 24) include 24 deserving students who received a collective \$112,000 in scholarships. The total number and amount of awards vary from year to year, based on the number of corporate donations and qualified applicants. These recipients were

selected from the more than 200 applicants who were vying for scholarships.

"We're always looking for ways to expand the program," explains Barnes. "We're hoping to raise awareness at the regional and branch levels of the Association and encourage shipmates to promote the program within their local communities. For example, a template for a press release about the start of the scholarship season is now available at [www.fra.org/membernews](http://www.fra.org/membernews) under Public Relations Resources. [You must log in to the website to access this page.] We invite shipmates and branches to fill in the highlighted blanks to make it relevant to their community and then send it to their local newspapers and media outlets."

## Donors and Partners

The Foundation's scholarships are funded by various donors and corporate sponsors. As previously mentioned, some scholarships were established with bequests from shipmates and others who remembered the FRA scholarship program in their wills or named the Association or Foundation as the beneficiary on a life insurance policy. These legacy gifts are simple to establish, but a donor's wishes to support the Foundation must be documented in writing. (See page 30 for more information.)

Contributions are also made by shipmates and others who simply want to support the program. Donations are accepted at any time, but some shipmates and branches choose to make a donation in person to the National President at the Association's annual convention. Because there are very strict rules about the types of gifts military personnel can accept, FRA also makes a donation to the Foundation in the names of our convention speakers rather than purchasing gifts for them. Other scholarships are funded on an annual basis by our affinity partners and other corporate donors. For example, Mercer (formerly Marsh) and GEICO support many FRA initiatives, including sponsorship of annual scholarships.

"Beyond providing scholarships to qualified and deserving individuals, the Foundation's mission includes educating Congress and the American public on how the service of current and former enlisted members of the Sea Services benefits the nation, preparing educational materials and conducting educational activities in support of the Foundation's work, engaging in charitable and educational activities in order to expand awareness and supporting the Foundation in conjunction with its annual awards," adds Barnes.





## The Impact of FRA's Commitment to Education

The FRA Education Foundation is also an outgrowth of FRA's commitment to education in general. FRA has been an outspoken advocate for enhanced education benefits for service members and veterans for decades and has been actively engaged in efforts to preserve and enhance those benefits. For example, FRA was instrumental in ensuring the Post-9/11 GI Bill benefit was available to military personnel who previously had no education benefits and included provisions allowing transferability of the benefit to family members. More recently the Association weighed in to secure in-state tuition for service members who may not be legal residents of the state in which they are attending college, and supports funding to strengthen the military's Tuition Assistance programs.

The scholarships presented over the past decades are a tangible demonstration of that commitment. Just since 2001, the FRA and the Foundation have provided 330 scholarships totaling more than \$1.4 million. As impressive as these totals are, it's hard to quantify the impact these scholarships have on the students who receive them. Awards have been presented to students from all parts of the country who have gone on to become doctors and nurses, lawyers, teachers, social workers, professional musicians and a wide variety of other chosen career paths — thanks in no small part to the support they received from FRA. These awards pay dividends for generations.

Every shipmate can take great pride in this long-standing tradition and can play a part in continuing it. There are two ways to help: contributing to the scholarship fund and encouraging deserving students to apply for these generous awards.

Donations to the FRA Education Foundation are welcome from individuals, organizations and businesses, and are tax deductible. In addition to promoting the Foundation scholarships in the local media (using the aforementioned press release template), new promotional materials are being developed to promote the scholarship offerings. Shipmates can also encourage family members and other eligible students in their community to submit applications.

"There are a lot of competing messages out there," says Barnes, "and there's a need to get the word out to prospective applicants. FRA national and regional leaders, branches and individual shipmates can really help us spread the word about this great program."

During the last seven years of my husband's military career in the Coast Guard Reserve, I was fortunate to work with military families as the Ombudsman-at-Large for the Reserve Force and I saw the need for educational support. Working as the Foundation's scholarship coordinator gives me the opportunity to work in two areas — education and the military family — that hold significance in my life.

"Great strides have been made in helping military families pursue higher education with the implementation of the Post-9/11 GI Bill and other programs, but there is still more need. It's particularly rewarding to know that the FRA Education Foundation and its scholarship program is helping to address that need."

## Candidates for National President



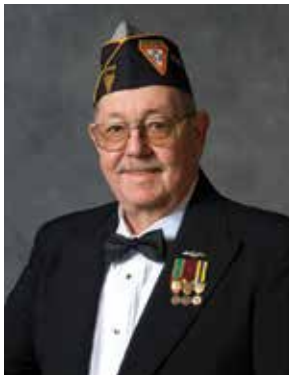
### **NP VIRGIL COURNEYA, BRANCH 274 (RENO, NEV.)**

## Oldest New Shipmate is a Pearl Harbor Survivor and First-Shot Veteran

**THE NEWEST MEMBER OF** Branch 238 (Plover, Wisc.) is 93-year-old Will Lehner. Shipmate Lehner is not only a Pearl Harbor survivor, but was on the destroyer that fired America's first shot in the Pacific theater of WWII an hour before the main Japanese attack on Pearl Harbor.

The *USS Ward* (DD-139), a WWI "four stacker," was not considered much of a fighting ship because of its age. The commander was Lt. William W Outerbridge, USN, and it was manned mainly by Reservists from the St. Paul, Minn.-based 47th Division. The *Ward* was on a seven-day patrol, beginning the evening of December 6th, the objective of which was to patrol the entrance of the harbor. At 0200 the minesweepers *Condor*, *Crossbill* and *Reedbird* started their Sunday morning patrol.

At 0400, the *Condor* radioed the *Ward* saying a submarine was sighted moving westerly at five knots. *Ward* went to battle stations and started to search. At 0605 the *USS Antares*, towing a 500-ton barge, "blinked" – someone was trying to follow it into the harbor. It appeared to be a periscope.

The attack began and *Ward* sent this message: WE HAVE ATTACKED AND DROPPED DEPTH CHARGES UPON A SUBMARINE OPERATING IN THE DEFENSIVE SEA AREA.

Historians credit the *Ward* with firing the first shot of WWII. Many historians also credit the *Ward* with sinking the submarine. Only two members of

the original crew are still alive — Will Lehner and Richard Thrill.

Lehner was on the National Geographic expedition that went looking for the sub. In August 2002, in the area where Lehner said the attack started, the Hawaii Undersea Research Lab discovered the sunken 78-foot two-man midget submarine in 1,200 feet of water with the crew still entombed. The submarine was in good condition and intact with a torpedo in each tube. It had a hole through the conning tower which confirmed the fact that the sub was hit during its dive.

Proving you are never too old to join the Fleet Reserve Association, Shipmate Lehner was glad to share his

experiences and said he hoped he contributed something to the war effort. Today, when he wants to swap war stories, he walks across the street where he talks with his neighbor, SGT John Reigner, who was on the team that liberated some of the German death camps with General Eisenhower.
