# Voter Friendly Ballot Act

This memorandum of support was sent to the Assembly Elections Committee by LWVNYS.

SUBJECT: AN ACT to amend the election law, in relation to enacting the voter friendly ballot act; and to repeal section 7-126 of such law relating to the form of ballots.

Purpose: To create a ballot layout that is easy for voters to read and use.

The League of Women Voters of New York State (the League) strongly supports this legislation to improve the ballot layout so voters will be able to read and mark their ballots more accurately and easily. New York State voters now use a paper ballot and optical scan voting machine system but the ballot requirements in New York State Election Law are based on obsolete lever voting machine standards. In November 2010 and again in November 2012 the League conducted a statewide survey of over 1,000 voters who used the paper ballot optical scan voting machines. A significant number of voters participating in both surveys indicated they had problems using the paper ballot and wanted an improved ballot design, which would enable them to mark their ballots with greater ease and accuracy. A ballot that is clear and simple to read makes voting easier and more accurate for voters to register their choices. The United States Election Assistance Commission (EAC) report, "Effective Designs for the Administration of Elections" cites guidelines for ballots for improved readability, usability and which would result in more accurate voting. A03389 amends the current election law to conform ballot requirements to meet these guidelines, which also have been recommended by the AIGA Design for Democracy project. The League supports the changes to New York State Election Law in this bill that achieve minimum uniform standards for all ballots used in the State and still provide flexibility for local boards of elections to achieve good ballot design. The League strongly supports this bill and urges your support.

### LANDFILL EXPANSION: We can make a difference. Testimony from Karen Harvey at the DEC Hearing on March 4<sup>th</sup>

"Do we receive high volume hydraulic fracturing waste at the Chautauqua County Landfill? The primary reason for loss of public and private water sources in Ohio due to storage of radioactive high volume hydraulic fracturing waste is because real time measurements of radiation using a Geiger counter at a landfill or water treatment plant - measures gamma rays from black shale generated waste which contains naturally occurring radiation from radium, radon and plutonium.

The problem is black shale radiation is Alpha and Beta radiation which cannot be measured with a Gamma Geiger counter. When drilling mud, HVHF cuttings, construction demolition debris or brine are stored or the leachate is sent through a water treatment plant in Jamestown the water soluble radioactive materials are concentrated but will not be discernible with an on site Gamma reading Geiger counter.

For an accurate reading, samples must be sequestered in closed containers for 21 days minimum to acquire their constituent parts to determine radioactivity. Minimum allowable radiation is 5 pico curies per gram or in water 5 pico curies per litre.

Are we testing the materials coming from Pennsylvania to our landfill, our leachate, our water after treatment for Alpha and Beta radioactivity? What regulations does New York State have in place to address Alpha and Beta radioactive waste?

# **Election Law Reform**

**Voter registration modernization, including same-day voter registration** - The League supports paperless forms of voter registration as a means of decreasing costs and increasing accuracy of the voter rolls. In 2013, New York moved a major step toward this goal by allowing secure online voter registration through the Department of Motor Vehicles. Ultimately secure online voter registration should be expanded to serve all eligible citizens. The League supports Election Day registration, registering and voting on the same day, as a proven method of increasing voter participation. The League supports preregistration of 16- and 17- year-olds to ensure that their voting participation is routine before they attend college or enter the workforce.

**Early in-person voting and no-excuse absentee voting** - While 32 other states have some form of early voting, New York only allows voters to cast their ballots on one Election Day, except in limited circumstances in which voters may vote by absentee ballot. The League supports implementing early voting to provide better access to the polls for all voters. We also support a constitutional amendment to allow for no-excuse absentee voting.

**Improvements to the way voters mark their ballots by better ballot design -** New York State voters now use a paper ballot and optical scan voting machine system, but current ballot requirements are based on obsolete lever voting machine standards. A clear and simple-to-read ballot would make voting easier and more accurate. The League supports improvements to ballot design that would include: (1) a clear delineation between offices with a bold vertical bar between offices and a fine line between the candidates, (2) a larger font with an absolute minimum size and (3) fill-in circles in black instead of gray.

### Healthcare

**Single-Payer** -The League supports a single-payer concept, which includes equitable access and cost containment, as the best approach to implementing League positions on health care. Public financing using general taxes would reduce costs significantly by lowering administrative expenses and coordinating regional planning as well as potentially lowering real estate taxes because Medicaid expenses (currently 40 percent) would be removed as a burden on counties.

**Other Healthcare Issues** - The League intends to continue our efforts to improve access and equity in health care. We will monitor a number of health care concerns such as: the allocation of medical resources to underserved areas, health promotion and disease prevention, school-based health services, women's health issues, cuts to the Tobacco Control Program, end-of-life issues, long-term care and prescription drug expenses.
