If you are a seafarer who is not a resident in the UK or any other European Economic Area (EEA) State you may be able to claim back any UK Income Tax deducted from your seafaring earnings.

Any income from duties carried out in the UK, or within the UK continental shelf will be liable to UK tax, as will duties carried out between UK ports, with no foreign port visit between.

However, any duties carried out outside that sector or on direct journeys between UK and foreign ports will not be liable to UK tax.
