COUNCIL TAX DISREGARD GUIDANCE NOTES

SCHOOL AND COLLEGE LEAVERS

This is defined as a person who:

- a) is under the age of 20; and
- b) has, within a relevant period, ceased to undertake a qualifying course of education or a full time course of education.

'Relevant period' means the period after 30th April and before 1st November in any year. The disregarded person will be disregarded during this relevant period.

Please attach a letter of confirmation of the above from the school or college.

PERSONS IN RESPECT OF WHOM CHILD BENEFIT IS PAYABLE

A person will be disregarded if he/she:

- a) has attained the age of 18 years but
- b) is a person in respect of whom another person is entitled to Child Benefit, or would be but for paragraph 1(c) of Schedule 9 to the Social Security Contributions and Benefits Act 1992.

Please attach proof of Child Benefit entitlement.
