#### **Project Overview**

The Central Geelong Artbox project is an opportunity for local artists to illustrate the identity and aspirations of the City through commissioning artworks on VicRoads traffic signal boxes.

The project builds on other highly successful Artbox projects undertaken by Council in the past five years, including in High Street Belmont, East Geelong and Moorabool Street, Central Geelong.

The Central Geelong Artbox project has three distinct aims:

- To provide an attractive, vibrant and colourful interface for the community and visitors at intersections in the Central Geelong Action Plan area.
- To complement existing urban, street and laneway art.
- To engage the Geelong arts community in a visible project with past proven success.

Artbox has proven to be a key opportunity for emerging artists and will enable the arts community an opportunity to start to engage more in the revitalisation of Central Geelong.

The theme for the Central Geelong Artbox project will be 'City Identity', including encouraging exploration of what 'a smart, thriving 21<sup>st</sup> Century City' is and what makes Central Geelong a memorable and exciting place to be.

#### **Project Scope**

The Central Geelong Artbox project timeframes are proposed (refer Attachment 1).

The first stage 'Project Scoping & Development' has been undertaken identifying scope, timelines, management of successful artists, theme and project documentation.

The 'Project Documentation' phase will include identifying traffic box locations, finalising the Artbox Project brief, artist contracts, communications activity.

An 'Expressions of Interest' phase will be launched and communicated to the public, including promoting the opportunity to artists through existing Arts & Culture mailing

lists. This phase will see the submission of Artbox submissions over a four week period. The process will be coordinated by a sub-contractor who has overseen previous Artbox projects.

Evaluation of submissions will be undertaken by the coordinating sub-contractor, Arts & Culture and Central Geelong Action Plan representatives. Successful artists will be notified by representatives and contracts signed.


The Artboxes are due for completion by mid July.

#### LITTLE MALOP STREET PEDESTRIAN & CYCLING BRIDGE

#### **Project Status**

Further to the endorsement of the study process by the Task Force on 13 April, the procurement for the design of the Little Malop Street pedestrian and cycle bridge is underway.

A brief has been developed and was sent to consultants for quote on the 21<sup>st</sup> of April 2015, including the delivery of a bridge over the rail line and streetscaping works in Little Malop Street from Latrobe Terrace to Fenwick Street. The quotation period closes on the 4<sup>th</sup> of May 2015 and anticipated award is expected to be announced in the week beginning 11<sup>th</sup> of May 2015.

Final design and all outputs are expected by the 31<sup>st</sup> of July (pending rail authority approval and permits). Final timelines will be confirmed following appointment of the consultant.

Quantity surveying will also be undertaken on the design following its completion to provide indicative costs for construction, informing the timing and phasing of delivery.

#### **Budget Status**

The 2014/15 budget set aside \$80,000 for improving pedestrian connections between Deakin & Gordon. The design of the bridge will be completed this Financial Year.

#### **Next Steps**

The following are the next steps to be undertaken:

- Award consultancy for design;
- Confirm required permits/licences;
- Undertake quantity survey.
