- ✓ Game length is 20 minutes x 2 halves.
- ✓ Travel Required:
- ✓ Age Divisions: 12U: (10-12yrs / 5th-6th grade), U14: (12-14yrs / 7th-8th grade)
- ✓ All Players will be drafted in order determined by league director. Only Head Coach and Assistant Coaches child can be protected in draft process. (Draft order of these players will be determined at Coaches Meeting)
- ✓ Age of participants is determined as of May 21, 2016
- ✓ Game Setup: U12 & U14 Play 5 v 5 ✓ Ball Size: junior football or intermediate football
- ✓ Travel Required: Games will be played at:  
CHASCO Family YMCA in Round Rock (the Boles Family Sports Complex - West Side)
- ✓ Weekday Game Times will be Fridays anytime from 6:00-8:00pm / Saturday Game Times: anytime from 8am-8pm
- ✓ One to two practices will be provided or arranged.
- ✓ Players must wear YMCA provided jersey all team jerseys.
- ✓ All players must wear mouthguards.
- ✓ Only registered players with the YMCA and NFL Flag are eligible to practice or play in a game.
- ✓ Uniforms are provided by NFL Flag Football (NFL Teams). Team requests are not available.
- ✓ All players and coaches must follow Y GUIDELINES (Coach's Conduct).
- ✓ Teams will follow rules set by NFL Flag Football. All Players must play a minimum of 1/2 the game.
- ✓ Mini Tournament Notes: All teams qualify for the season end consolation style tournament and are guaranteed at least two games. Seeding is based on overall record of season play. Awards will be given to top 3 teams at conclusion of tournament.
- ✓ Players and Coaches will be required to sign up with NFL Flag/USA Football to complete registration. Link will be emailed to participant after registration with the YMCA is complete.
