Non-lodgment advice

The ATO is authorised by the Taxation Administration Act 1953 to request you to quote

your tax file number (TFN). It is not an offence not to quote your TFN. However, your TFN helps the ATO to correctly identify your tax records.

If you do not need to lodge a tax return for the 2012-13 income year (1 July 2012 to 30 June 2013), you will need to complete the form below and send it to the ATO by 31 October 2013.
