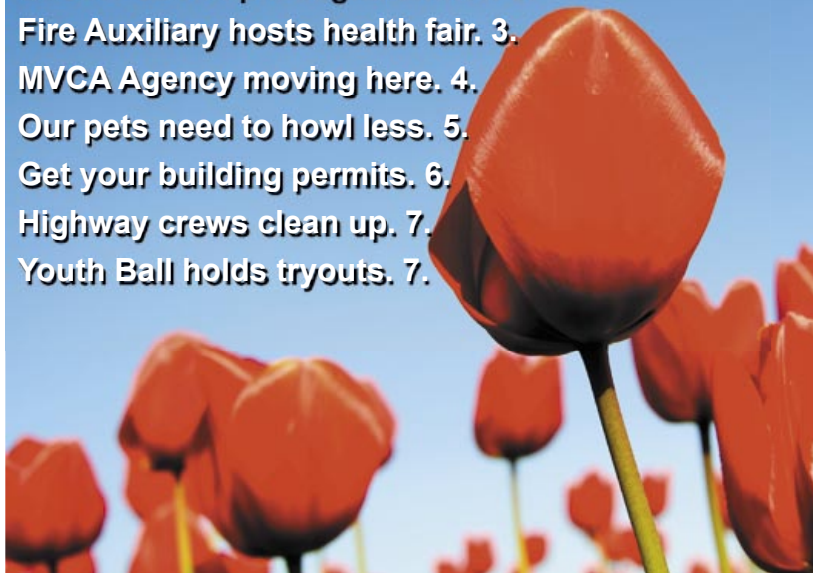

MESSAGE FROM THE SUPERVISOR

Issues Affecting All of Us And Other Topics

As we move into Spring, there are many issues going on that will have an effect on all of us. The frustrating part is that we do not control these issues or in most cases the outcome.

The issues are:

- Water,
- NYRI,
- Fuel Products,
- Assessment Challenges.

This past year we saw water become a shortage within our region and it almost affected our individual consumption. In the early 1900's water usage and rates were established for us to use. Around 1912 or so, water use was established for canal usage for interstate commerce. Since this time two major changes affecting usage should have been addressed as it relates to regulating where water goes. The NYS Thruway was built making interstate commerce on the roadways, not by water. Most paper mills, which used a large portion of the daily water flows, have closed down. Two agencies must change how they operate as it relates to our water, NYS Department of Environmental Conservation (DEC) and NYS Canal Corp. Officials at Mohawk Valley Water Authority (MVWA) are cor-

rect when they state – “we do not have a water shortage issue in our region”.

New York Regional Interconnect (NYRI) is the proposed power transmission line from Edic Road to New York City. This proposed line is designed to travel through the Marcy NANO site at SUNY IT. Marcy NANO is the region's hope for economic recovery. Our state does not have an updated energy plan and the Federal government has made our region part of its energy corridor. This has let ideas like NYRI to take place. Our community will fight this proposed power line with other communities, but we have the most at stake since it starts in Marcy, then splits the Marcy NANO site in two.

With oil hitting \$100 a barrel, our fuel and fuel-related product costs to accomplish services has skyrocketed. Just as all of you have been hit hard with high home, business and transportation expenses, the same has happened in running your Highway, Sanitation, Sewer and Town offices. We have lowered thermostats, eliminated unnecessary travel, but we need help from the weather. Both the cost of oil and

weather patterns are beyond our control.

Once again we have been challenged by a major company wanting their assessments lowered and taxes refunded, affecting County, Town and School taxes. Companies that have challenged us have seen major profits but yet feel their buildings and transmission lines are worth less. I disagree. The process for us to challenge is costly with the outcome pre-decided by others. This current one has not been finalized.

OTHER TOPICS

The cost to fix the pool, pool building and filtration system is in excess of \$400,000. A Request For Proposal (RFP) has been written to obtain firm costs and is currently being reviewed by the Town Board.

Legal proceeding on the new municipal building is still pending between the town, general contractors and architect. Main issues are with the roof, installation and non-completed items.

Sen. Griffo Addresses Chamber

*Annual Meeting
Held at SUNYIT*

State Sen. Joseph Griffo delivered the keynote address as SUNYIT hosted the Marcy Chamber of Commerce annual meeting and induction of board members January 30 in Café Kunsela. Chamber members were joined by Marcy Town Supervisor Brian Scala and several SUNYIT faculty and staff at the event.

Griffo, a Republican serving his first term in the State Senate, said his duties comprise three main priorities: attending to constituent needs, advocating for communities in his district and supporting policies that will have a dramatic impact across the state. During the current session, he said the

All in all, Griffo said, "It's going to be an interesting year."

Community Action Agency Moving to Marcy

Mohawk Valley Community Action Agency is moving to Marcy April 1. The anti-poverty agency that serves some 10,000 families each year in Oneida and Herkimer counties has decided to move its administrative offices to 9882 River Road.

Executive Director Amy Turner said that approximately 60 employees will move into the two-story, brick building.

"We are pleased that you selected a location in our town and we look forward to developing a good working relationship with Community Action," Town Supervisor Brian Scala told Turner during a recent tour of the building.

The agency's board selected

Marcy over several other sites because it is centrally located for residents of both Oneida and Herkimer counties, Turner said.

Community Action's child development, housing and family service offices will occupy the front half of both floors of the building facing River Road. The agency has an option to expand into additional areas

of the building at a later date, Turner said.

Community Action had operated administrative and customer service offices in the former City Hall building in Rome for two decades. Customers in Rome and western Oneida County will continue to obtain services from new offices being set up in Rome, Turner said.

Spring is upon us – and very welcome as always after the cold and gray of winter.

This spring brings some changes in terms of the town regulations in barking dogs and other animal noise. On December 27, the Town Board enacted a Noise Law which is eight pages in length and addresses all kinds of disruptive noise. I will only address the barking changes: a dog may only bark continuously for a period of 10 minutes or intermittently for 30 minutes before it must be brought into the house or otherwise confined to cease the noise. This is a change from the former 45-minute law stipulation.

This Law also applies to other animals – screeching large birds, yowling domestic cats or any other pet animals that could constitute a disturbance.

Farm animals are not subject to this law.

If anyone has a complaint regarding lengthy noise, it may be reported to me, and hopefully the matter can be resolved. However, if I cannot be reached, the Oneida County Sheriff’s Department may be notified. (The Sheriff’s Department should not be notified for other dog control issues such as dogs running loose, biting dogs, dog fights, lost dogs or other canine issues as these problems are not within the realm of the new noise law.) The above stated limits in barking are from 7 a.m. to 10 p.m. weekdays and 9 a.m. until 10 p.m. on Sundays.

This brings up a second issue, which is having dogs outdoors on leads, in pens or in any other manner when no one is at their residence for lengthy periods of time – such

as when the family is at work or school all day. In addition, dogs may not be left out continuously at night between 10 p.m. and 7 a.m. All of this will be addressed more forcefully to ensure peace and quiet as well as the well-being of the animals involved.

As our Town grows and neighbor proximity becomes closer, I am encountering a much higher volume of complaints. People have different tolerance levels of noise and what may be ignorable for some is unbearable for others; thus, the stated time margins will be observed. Violation of the Law may result in issuance of a bench ticket answerable in Marcy Town Court with possible fines. So, everyone, please take heed and comply, dog owners and dog complain-ers alike. If you can, try to compromise with your neighbor first. Should that fail, call me to deal with the problem.

Let’s enjoy the coming season. Keep your pets controlled. Keep them healthy by using Frontline to control fleas and ticks. Heartworm is needed to control mosquito-transmitted disease. Remember to always provide adequate, unspillable water, and protection from hot sun and rain.

A Rabies Clinic will be held from 5 to 7 p.m. May 6 at Marcy Highway Garage, 9455 Toby Road. The cost is \$5.00 per animal. One-year vaccines will be dispensed unless you have your pet’s last rabies vaccine certificate. If your dog license is expired, you may renew it at that time. Original licenses will also be issued. The fee for a female spayed or male neutered dog is \$2.50 and for an unsprayed or unneutered dog, the fee is \$10.50. Of the total license fee, 53% remains with the Town. *Reminder:* When renewing your dog license by mail, please include a self-addressed stamped envelope.

Highway & Sanitation Department Notes

The Highway Department completed many projects during the winter season.

Sand and salt screens were built for the plow trucks purchased last year; they were built in-house, saving money compared to buying them with the vehicles. Repairs were made to some snowplows that had excessive wear. All regular-run snowplows now are equipped with sanders. This cuts down on sander truck routes and makes our town roads even safer.

Summer equipment and mowers are being serviced and made ready for the sea-

son. Summer road work is being planned. As soon as the weather clears, Highway crews will be out to clean up after the winter season. Piles of sand may be placed at the roadside for pickup. Please keep piles clear of mailboxes and other obstructions.

SANITATION DEPARTMENT

Spring yard cleanup is just around the corner. Just some reminders regarding green waste collection.

Yard debris is collected weekly on your regular garbage day. Small yard waste such as leaves and grass clippings must be put into CLEAR bags not to exceed 40 lbs. No loose piles will be collected.

Tree trimmings and branches should be cut in 8-10 foot lengths and not exceed 10" in diameter. Limbs need to be placed with the cut ends to the roadside. Please limit piles to

4 feet high by 8 feet long per week.

Regular collection schedule is in place year round to get rid of specialty items. Schedules can be found on line at www.townofmarcy.org or at the Town Hall during business hours. Please check your schedule before placing items to the roadside and do not place them out for collection more than 24 hours in advance.

Contractors, tree services and landscapers must remove the waste they generate.
