In the event of CPU failure, a CPU with a

Passmark CPU Mark rating of 3000 or higher would be used. In the event of a part failure, an equivalent device would be installed since original parts may not always be available.

When service is needed, the Purchaser should call the Seller at _____. Seller will pick up the computer within 24 hours, if possible. As needed, the computer may be taken to the Seller's office for repair and returned as soon as possible. In the event, the Purchaser moves further than 25 miles from his current residence, delivery would be made by the Purchaser to the Seller's office.

The following are being provided, at time of sale, to the Purchaser:

- (a) Computer
- (b) Wireless Keyboard and Mouse

The following will be provided to Purchaser at conclusion of the 6 month warranty period:

- (a) Backup Restoration based on operating system in place at the time
- (b) Diskettes for the motherboard operating system in place at the time

Any work done inside the computer by the Purchaser or Purchaser's designate during the warranty period voids the warranty.

This warranty is not transferable. In the event of death of either party to the contract, the warranty will be void.
